Donna will contact Brian Prince for an estimate also for Norton Hill Road for prep of surface for paving and get recommendations for contractors for paving estimates needed.

• Grate & coat Mountain Road- open discussion on costs already paid out to continually keep road in safe and passable condition. Estimates will be needed, 50 feet on either side of bridge is maintained by the county. Bill reminds council that Vestal materials for roads are superior product that lasts longer. Bill & Joe will take the lead in investigating all options. Diane gives the name & email of local supervisor at county level who has agreed to come to view Mountain Rd and make recommendations including grant possibilities.
