Palm Beach Club Services LLC d/b/a Carriage House Palm Beach, located in Palm Beach, Florida, seeks seven (7) full-time, temporary Bartenders who will be responsible for greeting customers, cleaning bars, work areas and tables, taking beverage orders from serving staff or directly from patrons, stock bar with beer, wine, liquor

and related supplies such as glassware, ice, napkins and straws, mix ingredients to prepare cocktails and other drinks, slice and pit fruit for garnishing drinks and arrange bottles and glasses to make attractive displays.

Will report directly to the Service Manager at Carriage House Palm Beach.

Three (3) months of experience in a fine-dining or high-volume environment at a high-end restaurant, resort, or private club required.

Applicant must complete pre-employment background check at employers expense.

All worksites located in Palm Beach County, Florida. Travel throughout this area may be required. Transportation between worksites is provided for worksites that are not within walking distance.

Daily transportation to and from worksite is provided by an employee shuttle for those living in employee housing.

On-the-job training is provided.

Tipped position with guaranteed wage of \$18.88 per hour, paid bi-weekly. Overtime is available at \$28.32 per hour. Employer will guarantee wage in any given workweek when total compensation (including tips) does not meet prevailing wage rate or overtime wage rate. Employee may be eligible for additional compensation in the form of discretionary returning and end of season bonuses, and an automatic gratuity that comes from members service charges.

Schedule: 40 hours per week. Work schedule can vary and can include evening, weekend, and holiday hours. Work may be performed on any day of the week from Monday through Sunday. Example shifts: 10:00am - 6:00pm, 12:00pm - 8:00pm, or 4:00pm - 12:00am. Shift hours may vary.

A single workweek will be used to compute wages due.

Optional housing is offered on a first-come, first-serve basis for workers who are relocating to begin employment. Cost of housing, if accepted, is \$350 - \$1,000 per bi-weekly pay period based on occupancy and includes all utilities. If used, total cost of housing will be deducted from paycheck. A \$250 security deposit is required, to be deducted from employees first paycheck.

Additional, optional benefits may be offered to worker, for workers sole benefit, including but not limited to a medical, dental, and vision insurance plan. If voluntarily elected by worker, employee costs/contributions for benefits will be deducted from paycheck.

All deductions from paycheck required by law will be made.

If the worker completes 50% of the work contract period, employer will pay directly for and/or reimburse workers for transportation and subsistence from the place of recruitment to the place of work. Upon completion of the work contract or where the worker is dismissed earlier, employer will provide or pay for workers reasonable costs of return transportation and subsistence back home or to the place the worker originally departed to work, except where the worker will not return due to subsequent employment with another employer. The employer will pay directly for and/or reimburse workers for all reasonable inbound transportation and subsistence costs within the first workweek. The employer will pay directly for and/or reimburse workers for all reasonable outbound transportation and subsistence costs during the last workweek. The amount of transportation payment or reimbursement will be equal to the most economical and reasonable common carrier for the distances involved. Daily subsistence will be provided at a rate of \$16.28 per day during travel to a maximum of \$68.00 per day with receipts.

The employer guarantees to offer work for hours equal to at least three fourths of the workdays in each 12-week period of the total employment period.

The employer will provide workers at no charge all tools, supplies, and equipment required to perform the job.
