The top three scams for 2019 involve one "oldie but goodie" and a couple of new ones, at least to us.

The first is the Microsoft Technician Scam. Someone calls claiming to be from Microsoft who has detected a problem on your computer. They will ask you to visit a few different websites to fix the problem. The caller is actually hijacking your computer. Microsoft **never** calls consumers.

If you fall for this one, it could lead to a scammer installing the FBI Moneypak virus on your computer. This virus appears as a warning on your screen that claims that it is the FBI telling you that they have locked your computer accusing you of viewing porn or illegally downloading music see how to unlock your computer here. It tells you to get a Green Dot Moneypak card worth several hundred dollars and enter the number on the screen. If you are really in trouble with the FBI they will not communicate with you like this. They will show up at your door.

The online rental scam most often runs through the Craigslist website but can appear in many places on the internet. The scammer places an ad for a rental property at a meager price. Through an email, they tell the victim that they are in a foreign country and just looking for someone to occupy the home and take care of the property during their absence. The scammer asks the victim to wire money for a rental deposit and the scammer disappears with your deposit payment.

The Green Valley Council (GVC) through its member homeowner associations represents over two thirds of



all Green Valley residents and is as close to a

local government as exists in this unincorporated retirement community. Frequent communication with County, State and Federal government officials has proved effective in getting things done

Some of the accomplishments of the council are:

• Worked with Pima County on the new Canoa Hills Trails Park. This is located on the former Canoa Hills Golf Course.

- Established a Preferred Vendor Program which provides Green Valley homeowners with well-vetted business and service providers.
- Median Green whose mission is to replant and beautify the public medians along our main thoroughfares for the benefit of both residents and visitors.
- The Health Fair which is held each year.

Courtesy Lights

Courtesy lights must be kept lighted during dark hours. If you are away, have someone responsible for the maintenance of the lights. Keeping your courtesy lights on while you are away will discourage break-ins. The Board has voted some changes to our lighting rules. They include the use of only yellow light bulbs, except for those fixtures that have candle lights. All yellow bulbs must not exceed 40 watts and the candle light may not exceed 15 watts (30 watts for two bulbs). Motion detection lights will still be allowed, however spotlight wattage cannot exceed 40 watts. Also, if you replace your light fixture it must be approved by the Architectural Committee.

Common Ground

Desert Hills 4 has 20 acres of common ground. We pay our landscaper more than \$40,000 a year to maintain the common ground. As homeowners, we cannot remove or add materials to the common ground. HOA guidelines must be followed to allow access by the fire department, if necessary, and keep the beauty of our community. Please do not add or remove materials from the common ground. Architectural Approval

According to Article X11 Section 3 of our CC & R'S... prior to any improvements all Owners shall be required to obtain the written approval of the Architectural Committee for any improvement to their property. A copy of the approval must be delivered to the Improvements include but not limited to the installation of light fixtures, cabling, radio antennae, television antennae, satellite stations such as cable television or dishes, painting exterior walls, patio walls, fences, copings, awnings, sunshades, flagpoles, landscaping, solar panels and any and all related matters such as gates, security and front doors.

Just as a reminder, if you have a project and you are unsure if you need an approval, please ask first by contacting the chairperson.

Certified Mailings

Occasionally your HOA sends letters to homeowners via certified mail. As most of you know, your HOA does not have an office. As a result, any certified letters to the HOA requiring a signature are not delivered to the HOA, but a notice is put in our local mail box and the letter is held at the post office for pick up. We ask that any of you who have certified letters to send to the HOA, please look at the website for the address of the appropriate person and mail the certified letter directly to that person. Waste Management

We are currently in year 2 of our five-year contract with Waste Management for garbage & recycling services. On 6/1/20 we move into year 3 and the monthly rate increases to \$14.85 per month (billed quarterly).

Some reminders:

- If you sign up for Paperless Billing and Auto Pay, the \$5.00 admin fee on your invoice can be waived. Register at www.WM.com.
- Garbage is picked up twice a week Mondays and Thursdays. Recycling is picked up once a week – Thursdays. Cans should be out on the curb by 7:00 am
- Approved recycling items include: magazines, office paper, brown paper bags, newspapers, paperboard, cardboard, paper cardboard (such as dairy and juice containers), junk mail, phone

books, glass bottles and jars, #1-7 plastic bottles and containers, aluminum cans and tin or steel cans.

• DO NOT PUT IN RECYCLE BINS: food waste, yard waste, shredded paper, films, plastic bags, plastic wrap or foam cups and containers.

Homeowners should contact WM Customer Service for starting or stopping service or vacation holds (greater than 30 days) at 520-744-2600. If anyone has issues with Waste Management service that cannot be handled through WM Customer Service please contact Phyllis Buchanan at 313-801-7723. She will contact Waste Management's HOA team to get the issue resolved.
