


**NOTICE OF SPECIAL MEETING
LEGACY WATER SUPPLY CORPORATION**

Notice is hereby given that the Board of Directors of the Legacy Water Supply Corporation (the "Corporation") will hold a special meeting of the Corporation's Board of Directors (the "Board") on **May 13, 2026, at 1:00 p.m. CST** at 1826 North Loop 1604 West, Suite 260, San Antonio, Texas 78248. The meeting will be open to the public and will be held to discuss and, if appropriate, act upon the following items:

- 1. Determine Quorum and Call to Order.**
- 2. Public Comments:** *This item is for any member of the public who wishes to address the Board of Directors. During the Public Comments portion of the Agenda, the presiding officer will call on those persons who have signed up to speak in the order they have registered. There will be no action by the Board of Directors at this time. Public comments will be limited to three (3) minutes per person.*
- 3. Public Hearing(s):** None.
- 4. Consent Agenda Item(s):** *The Consent Agenda is considered routine and will be enacted by the Board of Directors with one (1) motion. There will be no separate discussion of these items unless they are pulled from the Consent Agenda upon the request of a Board Member.*
 - a. Consider approval of the Minutes from the following Legacy Water Supply Corporation Meeting:
 - i. Minutes of the Board of Directors Meeting held on April 30, 2026;
- 5. Action/Discussion Items:**
 - a. Receive status updates on construction schedule and permitting activities related to the Corporation's Interim Water Treatment and Permanent Water Supply Project from Project Control;
 - b. Receive status updates on pursuit of state and federal grants and other funding for Regional Wholesale Water Project from General Counsel, Gene Lindgren, and Bond Counsel;
 - c. Receive status update on Corporation's efforts through Groundwater Management District ("GMA") 13 and report on Groundwater Availability Model ("GAM") simulation(s) and Desired Future Condition(s) ("DFC") by General Counsel for the Corporation and consider and take possible action in connection therewith;
 - d. Receive updates and/or presentation of formal rate study for wholesale water being conducted by NewGen Strategies & Solutions;
 - e. Consider and take possible action on Resolution Adopting Formal Rate Study Report conducted by NewGen Strategies & Solutions and Adopting Wholesale Rates as provided therein; and such other related actions incidental thereto;
 - f. Receive status update on contract negotiations with the City of Laredo, Texas, Webb County, Texas, and the Corporation pertaining to the Multi-Party Agreement and the Wholesale Water Purchase Agreement, and take possible action in connection therewith;
 - g. Consider and take possible action approving and authorizing execution of a Multi-Party Agreement between the Corporation and the Legacy Municipal Management District, Webb County, Texas, and the City of Laredo, Texas, Relating to the Corporation's Wholesale Water Supply Project.

- h. Consider and take possible action approving and authorizing execution of a *Wholesale Water Supply and Services Agreement* between the Corporation and the Legacy Municipal Management District;
 - i. Consider and take possible action regarding tentative meeting dates for the Corporation.
 - j. New Business/Future Agenda Items; and
6. **Executive Session:** No action shall be taken in Executive Session. A closed Executive Session may be held if the discussion of any of the above agenda items concerns any one of the following items listed below:
- a. Seeking the advice of General Counsel concerning pending or contemplated litigation, settlement offers, or any matter in which the duty of General Counsel to the Board of Directors of the Corporation under the Texas Disciplinary Rules of Professional Conduct clearly conflicts with the Texas Open Meetings Act (TEX. GOV'T CODE § 551.071);
 - b. Deliberating the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the Corporation in negotiations with a third person (TEX. GOV'T CODE § 551.072);
 - c. Deliberating a negotiated contract for a prospective gift or donation to the Corporation if the deliberation in an open meeting would have a detrimental effect on the position of the Corporation in negotiations with a third person (TEX. GOV'T CODE § 551.073);
 - d. Deliberating the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or to hear a complaint or charge against an employee or officer unless the officer or employee who is the subject of the deliberation or hearing requests a public hearing (TEX. GOV'T CODE § 551.074);
 - e. Deliberating economic development negotiations or the offer of a financial or other incentive to a business prospect (TEX. GOV'T CODE § 551.087);

- a. Consider and take possible action on any item discussed in Executive Session.
