

AMENDED NOTICE OF SPECIAL MEETING LEGACY WATER SUPPLY CORPORATION

Notice is hereby given that the Board of Directors of the Legacy Water Supply Corporation (the "Corporation") will hold a special meeting of the Corporation's Board of Directors (the "Board") on **August 19, 2025, at 9:00 a.m.** at 1826 North Loop 1604 West, Suite 260, San Antonio, Texas 78248. The meeting will be open to the public and will be held to discuss and, if appropriate, act upon the following items:

1. **Determine Quorum and Call to Order.**
2. **Public Comments:** This item is for members of the public to address the Board of Directors on issues and items of concern not on this agenda. There will be no action by the Board of Directors at this time.
3. **Public Hearing(s):** None.
4. **Action/Discussion Items:**
 - a. Briefing on the status of efforts by the Area Groundwater Utility Agency ("AGUA") to establish and obtain funding for a sustainable groundwater resource and economic development project in the Webb County area (the "Regional Project") pursuant to the interlocal agreement between the Corporation, the City of Laredo (the "City"), Webb County (the "County"), the Legacy Municipal Management District (the "District");
 - b. Discussion of and possible action on an interlocal agreement between the Corporation, City, County, and District to jointly fund and participate in a water analysis and blending study related to the Regional Project to be carried out by the Corporation, for the benefit of the parties to the agreement;
 - c. Discussion of and possible action on an interlocal agreement between the Corporation, City, County, and District for jointly funding and participating in the Regional Project;
 - d. Discussion and possible action on establishing terms for standard groundwater lease agreements;
 - e. Discussion and possible action on establishing terms for standard wholesale water supply agreements.
5. **Executive Session:** No action shall be taken in Executive Session. A closed Executive Session will be held to seek and receive advice from legal counsel and for discussion of any of the above agenda items for the following purposes:
 - a. Seeking the advice of General Counsel concerning pending or contemplated litigation, settlement offers, or any matter in which the duty of General Counsel

to the Board of Directors of the Corporation under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act (Tex. Gov't Code § 551.071);

- b. Deliberating the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the Corporation in negotiations with a third person (Tex. Gov't Code § 551.072);
- c. Deliberating a negotiated contract for a prospective gift or donation to the Corporation if the deliberation in an open meeting would have a detrimental effect on the position of the Corporation in negotiations with a third person (Tex. Gov't Code 551.073);
- d. Deliberating the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or to hear a complaint or charge against an employee or officer unless the officer or employee who is the subject of the deliberation or hearing requests a public hearing (Tex. Gov't Code § 551.074); or
- e. Deliberating economic development negotiations or the offer of a financial or other incentive to a business prospect (Tex. Gov't Code § 551.087);

6. Reconvene in open session.

7. Adjournment

The Corporation may meet in executive session on any item listed above as authorized by the Open Meetings Act, Tex. Gov't. Code Ann. Chapter 551 or by Texas Government Code Section 418.183.
