Please provide all communications between Lindsay Short and any and all email addresses of Stephen Richer, former Maricopa County Arizona Recorder from Mrs. Short's official USAO email. Please provide any documentation produced for, or as a result of, these meetings. The calendar reviewed includes what appears to be a sanctioned DOJ activity, utilizing a non-governmental email, in conjunction with the former recorder, that suggest a coordinated effort to influence judges. It is imperative that the public understands the DOJ role quickly. In addition, Election litigation is always ongoing over any number of questions that need answered and resolved. It is imperative that the information gained from this FOIA is filled expeditiously to prevent any loss of due process.
