Arizona LD23 House Candidate Matias Rosales Is there Corruption in San Luis Arizona: Financial Impropriety and Ballot Harvesting?

On June 2nd, 2023, Nieves Riedel, the Mayor of San Luis, issued a letter of concern to Attorney General Kris Mayes regarding alleged financial improprieties by San Luis Council Member and current LD 23 Arizona House Candidate. Matias Rosales.

The letter states, "This letter is being written out of concern of possible problems with the handling of public monies and property..". The Mayor asked Attorney General Mayes to investigate the personal business conflicts and financial gains of Mr. Rosales and his company Realty One. Did Mr. Rosales use public funds to enrich himself and his political allies and then conceal financial evidence from the Mayor? Although the AZ Attorney General's Office issued a letter on

February 28th, 2024 stating that the office "considers this complaint closed". They also indicate that they "relied on publicly available information". This should make a person question if a real investigation was even conducted by the AG's Office. Did the Mayor's concerns get buried by his

Perhaps we must look at other aspects of Mr. Rosales' career to determine if this is in line with his character. On December 13th, 2023, Gloria Torres, a convicted 2020 ballot harvester (while still on probation) was appointed to serve as the

Gloria Torres was indicted for two felony counts of conspiracy and ballot abuse and pled guilty to a plea deal. In addition to believing Gloria would be best suited to serve as Vice-Mayor of one of our Arizona towns, her co-conspirator, former Mayor Guillermina Fuentes, has been one of Mr. Rosales' most loyal campaign workers and donors for his 2024 Arizona House Campaign. Guillermina was sentenced to jail time and probation for her part in the 2020 election fraud.

Is it also possible that Mr. Rosales is using his influence, city facilities, time or public resources as a city councilman to influence an election? According to the Attorney General Kris Mayes, the Arizona statutes are quite broad.

'Arizona's statutory prohibitions are quite broad, including "the use or expenditure of monies, accounts, credit, facilities, vehicles, postage, telecommunications, computer hardware and software, web pages, personnel, equipment, materials, buildings or any other thing of value." A.R.S. § 11-410(A). Although broad, this list is consistent in applying only to a "thing of value." See id. A violation of the statutory prohibitions must therefore involve the use or expenditure of a public resource that has value. In addition to the specific examples given in the statute, this prohibition also generally applies to the use of a public employee's time during normal working hours, as that time is a public resource that has value. Employees' time spent outside of normal working hours is not a public resource. " (Excerpt from : https://www.azaq.gov/opinions/i15-002-r15-002)
