

There is an effort underway to undermine the Arizona 2024 Delegation and Arizona's America First Grassroots. An attack on one of us is an attack on all of us. The Arizona Delegates stand together for each other, for Arizona, and for President Trump. Six of the Arizona National delegates have been challenged and an attempt is being made to remove these duly elected Pro-Trump delegates from being seated and replace us with their preferred RNC loyalists who not only lost their elections, but are also suspected of being part of an anti-Trump establishment group. At least one of these challengers has been reported to have worked with the anti-Trump faction in 2016 to attempt a brokered convention that would replace Trump with Ted Cruz. Two of the additional challengers have received funding from Jim Laymon, a publicly known Never-Trumper and a former Senate Candidate who held fundraisers to support DeSantis after Trump refused to endorse him. Another challenger works with a Yuma sector of Uniparty operatives who have funded efforts to block ballot harvesting investigations and funds Democrats.

We have learned that our political adversaries are using operatives from within the RNC itself to undermine Arizona and have included them in this lie. The challenges have been drafted by the RNC's very own Legal Counsel, Dhillon Law Firm.

At the meeting, our delegation, voted on a plan by our National Committeewoman Elect Liz Harris and presented for a vote by Arizona Delegation Chair Elect Shelby Busch, to reaffirm our commitment to President Trump and to support President Trump no matter what the outcome of his false kangaroo court sentencing and we are still committed to doing so.

Of the six challengers, only one was actually present at our meeting, Yvonne Cahill, who has targeted these same individuals being challenged for the last two years, simply because we are part of the Maricopa County Republican Committee (MCRC) who stand up for the voice of the grassroots Precinct Committeeman and refused to support her ally, the power hungry and corrupt prior Arizona Chairman Jeff DeWitt, who resigned in shame after being exposed for a bribery scheme against Kari Lake and her other DeWitt allies.
