RULES AND REGULATIONS FOR EXHIBITING

1. Exhibits must be the property of the exhibitor. Anyone may enter.
2. Entries must be made on the enclosed entry blank, copies are acceptable. Exhibitors may enter up to two exhibits, subject to availability. Please complete one form for each exhibit. Entries will be accepted as received until all frames are filled. **All exhibits must be either two, three or four frames.**
3. Exhibits will be mounted in "Ameripex" style frames holding sixteen 8 1/2" x 11" pages, eight 11" x 17" pages or the equivalent in larger pages. **Plastic sheet protectors are required.**
4. Exhibits should be sent to the address on the application. Exhibits not removed by the exhibitor will be returned by USPS Express Mail, uninsured, unless noted on the entry form and the proper return fees enclosed.
Mailed in exhibits must be received no later than Monday, March 2, 2026.
5. Set-up and take-down of the exhibits will be supervised by the Exhibits Committee. Exhibitors are encouraged to handle their own exhibits. **Exhibit set up time will be Saturday, March 7 from 8:00am to 9:30am.**
6. **Exhibits shall not be removed prior to 3:00pm Sunday, March 8.**
7. Insurance is the sole responsibility of the exhibitor. Although due precaution will be taken to safeguard the exhibits, no responsibility of any kind shall attach to the Rockford Stamp Club, Forest Hills Lodge or their agents, officers, employees, volunteers or any other person authorized to perform any duties in connection with the exhibits.
8. Judging will be on an open basis and the decision of the jury is final. Grand and Reserve Grand awards will be presented at the awards banquet Saturday night. Large Gold, Gold, Large Vermeil, Vermeil, Large Silver, Silver, Silver-Bronze and Bronze awards will be awarded at the judges discretion. Additional philatelic society awards will also be presented.
