





THE FIRST MARIAN APPARITION IN THE AMERICAS




The Tilma: The image has remained intact with all its original vibrancy for 475 years. The natural life span of a cloak made with fiber from the agave or maguey plant is only about 30 years. It remains on display today.

The miracle of Our Lady of Guadalupe involves the Virgin Mary's miraculous appearances to Juan Diego on Tepeyac Hill in 1531, where she instructed him to build a shrine. Sharing the message with Bishop Juan de Zumárraga who requested proof of the apparition, Juan Diego returned to the site.

Upon his return to the hill, he encountered our Blessed Mother once again. The Virgin told him to climb to the top of the hill and pick some flowers to present to the Bishop. Although it was winter and nothing should have been in bloom, Juan Diego climbed the hill where the Virgin bundled the flowers and placed them into Juan Diego's tilma (cloak). When Juan Diego presented the tilma of exotic flowers to Bishop Zumárraga, the flowers fell out and he recognized them as Castilian roses, which are not found in Mexico. Even more miraculous, the tilma had been imprinted with a colorful image of the Virgin herself.







"an alien apprehended while entering or attempting to enter the United States at a time or place other than as designated by immigration officers shall be subject to a civil penalty."

U.S. Dept. of Justice: Non-U.S. Citizens in the Federal Criminal Justice System, 1998–2018

Institute of Taxation & Economic Policy (ITEP): Tax Payments by Undocumented Immigrants

RELEASED: July 30, 2024

- Undocumented immigrants paid \$96.7 billion in federal, state, and local taxes in 2022. Most of that amount, \$59.4 billion, was paid to the federal government while the remaining \$37.3 billion was paid to state and local governments.
- More than a third of the tax dollars paid by undocumented immigrants go toward payroll taxes dedicated to funding programs that these workers are barred from accessing.
- Undocumented immigrants paid \$25.7 billion in Social Security taxes, \$6.4 billion in Medicare taxes, and \$1.8 billion in unemployment insurance taxes in 2022.
- Income tax payments by undocumented immigrants are affected by laws that require them to pay more than otherwise similarly situated U.S. citizens.

- Up to 75% of undocumented immigrants pay federal, state, and local taxes.

THE FACTS... IMMIGRANTS & TAXES

- For each year from 1994 to 2023, the US immigrant population generated more in taxes than they received in benefits from all levels of government.
- Over that period, immigrants created a cumulative fiscal surplus of \$14.5 trillion *in real 2024 US dollars*, including \$3.9 trillion in savings on interest on the debt.
- Without immigrants, US government public debt at all levels would be at least 205 percent of gross domestic product (GDP)—nearly twice its 2023 level.

Compliance Requirements for Undocumented Workers

- In 1996, the IRS created the Individual Taxpayer Identification Number (ITIN)
- ITINs are a tax processing number issued by the IRS for taxpayers who are not eligible to obtain SSNs
- Individuals eligible for an ITIN include:
 - Unauthorized immigrants,
 - Lawfully present individuals, and
 - U.S. resident aliens/nonresident aliens

Social Security Numbers vs. ITINs

What is an ITIN?

- Generally for federal tax filing purposes only
- 9-digit numbers and begin with "9"
- Does not confer immigration status or work authorization
- Cannot be used after obtaining SSN
- Some other limited uses

- Bought, borrowed, stolen or fake social security number



THE FACTS... IMMIGRANT PATHWAYS

Why Don't Unauthorized Migrants Come Here Legally?

- No “line” is available for the vast majority of undocumented immigrants.
- Many undocumented immigrants are barred from obtaining legal status while inside the United States.
- Family-based immigration is limited to certain close family relationships and is numerically restricted
- Employment-based immigration requires a U.S. employer to request specific foreign workers

Yes. All undocumented males 18 through 25 years of age, other than those admitted on non-immigrant visas, must register, whether or not they have a green card.

Those were some of the post-election reactions in schools across Wisconsin this week, many of which spilled directly into the laps of educators tasked with keeping decorum and maintaining neutrality after a national campaign marked by anything but propriety.

While American parents parsed their feelings, their children took stock of their own emotions, from celebratory to satisfied, resigned to anguished. Educators capitalized on their interest in a controversial election: What better time to understand the electoral college? But other teachable moments arose over civil discourse, with school leaders seeking to quell inflammatory post-election comments between students.

That happened at the city's best-known Catholic high schools — Divine Savior Holy Angels and St. Francis de Sales.

CHANGES TO CURRENT IMMIGRATION POLICY

Attempts to close U.S. Asylum System at southern border (paused)

Who was previously eligible?

- Must apply at port of entry or from within the U.S.
- Must be within 1 year of arrival
- Must provide evidence they have suffered persecution in their home country on account of a protected ground in the past, and/or they have a well-founded fear of persecution in the home country.



CHANGES TO CURRENT IMMIGRATION POLICY

U.S. Department of Homeland Security encourages DACA recipients to “self deport.”

- Flight will be paid for

RECENT U.S. SUPREME COURT DECISION

Noem v Vasquez Perdomo

SCOTUS ruled that the practice of randomly stopping and detaining individuals with Hispanic characteristics can resume until the case is fully heard.

- Allows federal agents to continue to racially profile Hispanics, if in addition to being Hispanic, they speak Spanish, live in Hispanic neighborhoods, and/or work in low wage jobs.
- Questioning and detaining individuals is a minor inconvenience when compared to the interest of the government.
