# What is Harold's House?

We are a Children's Advocacy Center designed to minimize the trauma of child abuse victims and their families as they work with law enforcement, prosecutors, and Child Protective Services.

We serve Angelina, Nacogdoches and Sabine counties.

Through the expertise of our Forensic Interviewers, a child can tell their story once, instead of multiple times, to those involved in their case. A Family Advocate then provides them with support, community referrals, and general information about victims' rights. The victim, as well as their family, are strongly encouraged to obtain mental health services through one of our trauma-focused counselors. If a medical exam is needed, we have on-site Sexual Assault Nurse Examiners (SANE) to perform forensic medical exams and well checks.

Harold's House also educates the community on detecting and preventing child abuse through trainings offered to any youth serving organization and school districts. In addition, we provide community parenting classes in surrounding counties in hopes of strengthening communication between parent and child.

-Harold's House partnered with Angelina College and Family Crisis Center in hosting the Coordinated Crime Conference that was held on July16-17 at A.C. This conference held workshops for Law Enforcement, Nurses, Social Workers, Advocates, Attorneys, Counselors and community members who have a direct interest in crime prevention.

-Harold's House has made updates to their building and security to better meet the needs for our clients and help accommodate our Multidisciplinary Team in seeing our high priority cases.

-Harold's House staff has partnered with Family Crisis center by creating a "Lets Talk About it" training. Staff have been speaking to several members of Angelina County schools. This segment talks about various types of abuse, body safety, and the process of reporting child abuse.
