With the exception of the Afternoon Matches, the First Match for each event will begin promptly at 0900.

**Afternoon Matches** will begin at 1745. There will be 3 such matches as an experiment to take advantage of late afternoon lighting conditions at the Academy range.

**1500 Matches** – These are being held to assist shooters in obtaining classifications quicker. You MAY, at your discretion, shoot the 480 round course of fire if you choose by shooting Matches 3 and 4 only. Either way, your percentage will be obtained for inclusion in Governor's 20 tabulations.

**Police Action matches** – these will be held after the PPC matches and 3-4 stages will be set up to run those choosing to participate through. Estimated round counts will be sent out by e-mail later.

**May 28 Shotgun Match** – this is the day before the Regional starts. You MAY, if you choose, shoot your Regional shotgun match on this date, but you MUST declare that you are doing so BEFORE going to the line and your score WILL be your Regional score – you will not be allowed to shoot it again when scheduled on Friday or Saturday.

#### Match Counts (Tentative, including Regional and Championship)

- Service – a bunch (about 30... depending on how you want to shoot Off Duty, etc. in Regional)
- Governor's 20
  - 480 Round – 45 to 47 (depending on how you handle the 1500'2)
  - 1500 – 7
- Distinguished (Revolver, Semiauto, Production) – 8 each
- Shotgun – 5
- Police Action – 2
- Rifle - NONE
