

# FOCUS ON CUMBERLAND COUNTY ANIMAL SAFETY Adoption Contract

Please read the following carefully:
The parties hereto agree that the owners shall abide by the following conditions:
the understanding that the adopter is taking possession of the cat to treat and to be responsible for it as their own cat.
___ The cat will be treated as a family member with loving care and affection. I will do my best to ensure the cat's safety and well-being.
$\qquad$ I/we will feed the cat at least twice a day and will provide a fresh supply of water at all times.
___ The cat will live inside my home and will not be isolated from the family.
$\qquad$ I will never let my cat run loose or roam. It will be indoors at all times.
__I will never allow any physical, mental, or emotional abuse of the dog/cat.
$\qquad$ I will take the cat to a licensed veterinarian when shots are due $\qquad$ , but in no event later than one year from the last vet visit.
$\qquad$ I will provide all required and/or needed veterinary care, including: rabies shots as required every one or three years; yearly booster shots for FVRCP; and prompt treatment by a licensed veterinarian for any illness or injury.
$\qquad$ If not already done, I will have the cat spayed/neutered by (date) $\qquad$ and will immediately forward proof to the FOCCAS office. Failure to comply with this requirement will result in the immediate return of the cat to FOCCAS. If any accidental breeding has taken place, kittens will be turned over
to FOCCAS and owner will be responsible for all legal fees.

I/we affirm that no member of my household has been convicted of an animal welfare law violation such as neglect, cruelty, abandonment etc.
$\qquad$ I will ensure compliance with all applicable local and state statutes.
I will not use a correction/prong style collar at any time, except for training under the guidance of a qualified trainer.
$\qquad$ I am adopting the cat for myself and I agree to not give away, sell, or trade my cat, even as a gift to a friend or family member.

I will neither take the cat to a shelter nor abandon the cat.
I understand that I must notify FOCCAS, without delay, if I can no longer care for or keep my cat and agree to give FOCCAS reasonable time to re-home my cat or place my cat in an approved foster home, if available. I cannot rehome my pet for any reason. NO EXCEPTIONS!

I must notify FOCCAS of any behavioral problems that have occurred at any time before I return my cat and I agree to pay for a professional trainer's evaluation in case of biting or aggression.

## If cat is removed from property, harmed, sold, or transferred without express written permission from FOCCAS, FOCCAS will pursue through the legal system for costs and damages, including all legal fees.

$\qquad$ I agree to accept responsibility and ownership of the cat at my own risk and I release FOCCAS and its agents from any and all liability arising out of possession and ownership of my cat.

I agree that I am assuming total financial responsibility for my pet as of the date of this contract. FOCCAS and its agents will not be held responsible for any damages or expenses (veterinary or other) incurred during my ownership of the cat.
$\qquad$ In the event the cat becomes lost or dies, I will immediately notify FOCCAS.
$\qquad$ I will immediately notify FOCCAS of any change of contact information (address, phone number, or email address).

This cat's known background and medical history have been discussed with me. I understand that FOCCAS has made no representation concerning the health, condition, training, behavior, or temperament of the cat.
$\qquad$ I agree to permit FOCCAS to make inquiry about and enforce any of the above conditions and requirements at any time after adoption. This can include visits to my home and contact with my veterinarian. I
UNDERSTAND THAT FAILURE TO COMPLY WITH ANY OF THE ABOVE PROVISIONS WILL RESULT IN FORFEITURE OF THE CAT TO FOCUS ON CUMBERLAND COUNTY ANIMAL SAFETY.

I understand that by voluntarily signing this agreement, I am entering into a legal and binding contract with FOCCAS. Breach of any term(s) of this agreement is deemed actionable by FOCCAS.
