Mare Owner and Stallion Owner agree to the following terms and conditions:

## **STALLION SERVICE PURCHASE PRICE**

| Mare Owner agrees to pay the Stallion Owner the total fee of <b>\$700 (SEVEN HUNDRED DOLLARS)</b> in U.S. Funds. Upon payment of the non-refundable <b>\$100 (One Hundred Dollars)</b> booking fee by Mare Owner to Stallion Owner, Stallion Owner does hereby agree to reserve for Mare Owner one breeding service booking for the year <b>2025</b> for the above listed mare.  |

| *Booking Fee paid on: ViaCheck VenmoCash  If breeding via shipped Semen, there is an additional collection fee of \$250.00 per collection, plus shipping (varies). The AHA Transported Semen Registration fee is covered in the stud fee.  |
| FEE DUE DATES  |
| For Transported Semen: The balance of the stallion service purchase price (\$600), semen collection fee (\$250.00), shipping fee (Varies) must be paid prior to shipment of Semen.   |
| For Local Artificial Insemination (AI): The balance of the Stallion Service purchase price (\$600), semen collection fee (\$250.00), and veterinarian AI Fees (Varies), must be paid prior to the mares arrival at vet clinic of choice. If Mare Owner is picking Semen up and taking to their vet, they will cover their vet expenses on AI. If the Mare is boarded at stallion facility, boarding fees must be paid on or before the date the Mare is released from Stallion Owner's possession. |
| Cash, Check, or Venmo accepted. All checks must clear by the payment due date. Any Venmo transaction fees will be added to the Stallion Service Purchase Price.  |

- 2. A copy of the mare's registration certificate shall be provided to Stallion Owner with this agreement.
- 3. All charges accrued due to collection and shipping of cooled semen (including re-breeding's) shall be paid directly to the Stallion Owner.
- 4. If using shipped semen, the Mare Owner agrees to comply with all AHA or other breed association requirements concerning the use of handling of transported cooled semen. The Stallion Owner will cover the \$35.00 (thirty-five dollars) that AHA (Arabian Horse Association) requires on shipped semen in order to register the result foal.
- 5. **The mare shall be in healthy and sound breeding condition**, free from transmittable illnesses or diseases. A **current** Veterinarian Health Certificate, **current** vaccination & worming records, a **current** breeding soundness exam report from the vet.
  - (a) If mare is found to be infected or otherwise no in breedable condition, the Mare Owner shall notify the Stallion Owner and agree upon a course of treatment to be paid by the Mare Owner. If after a diligent effort has been expended by Mare Owner, the mare does not settle by the end of the current breeding season year (July 31st) the Mare Owner shall hold the Stallion Owner blameless and a refund of half the stud fee will be made.
- 6. **Live-Foal Guarantee**: If the Mare is barren, aborts, or fails to produce a single live foal that can stand up unassisted and nurse, Stallion Owner will allow Mare Owner to a return breeding privilege of the Mare to Stallion (or a substitute mare, if acceptable to Stallion Owner) in the next breeding season only, provided that Mare Owner furnishes a satisfactory certificate issued by a licensed Veterinarian attesting to either occurrence within thirty (30) days of occurrence. Mare Owner agrees to pay for all expenses involved or incurred in the re-servicing of the mare, including but not limited to boarding fees and expenses veterinarian fees, and if using shipped semen, an additional chute fee, collection and shipment fees for a re-breed conducted after the first year of service. The Mare must be delivered to Stallion Owner's farm (for live cover) for a re-breed by July 1<sup>st</sup>, then all fees paid shall not be refundable and this contract is hereby cancelled.
- 7. If for any reason the Stallion covered by this agreement should die or become unfit for service prior to breeding the Mare, the breeding fee will be refunded.
- 8. If prior to the breeding of the Mare, said Mare dies or becomes unfit for service, as declared in writing by a licensed veterinarian, this agreement shall become null and void and the Stallion Service Purchase



Price, not including the booking fee, shall be refunded to the Mare Owner. The Mare Owner will be required to pay all boarding fees, veterinarian expenses and any other expenses.

- 9. This agreement may not be assigned, transferred, or sold without the prior written consent of the other party and shall be binding upon the parties thereto, their heirs, executors, administrators, or assigns.
- 10. The Stallion Owner reserves the right to use the names and photographs of the Stallion's foals for advertising purposes.
- 11. Mare Owner will be solely responsible for seeking registration of the foal in the appropriate breed registry(s) and will pay all associated fees or expenses. A Breeder's Certificate will be issued by the Stallion Owner after all monies have been paid in full by the Mare Owner.
- 12. Any disputes will be settled in and by the laws of the state of Idaho.

The undersigned understand and agree to abide by all the stipulations set forth in this contract.
