Zone 4: Boardwalk (SID) Only						
Place Trash Cans and Recycling at curb, not in the middle of the street end. Winter Schedule follow Zones 1, 2 and 3 Pick-up days.						

RESIDENTIAL BULK ITEM PICK-UP: Is available for residential properties only during last standard trash pick-up day of each month and by each zone. Excluding July and August.

Excluded items from bulk pick-up: Mattresses, Tires, Petroleum Products, Hazardous Materials, Construction Materials or Debris, Items over 75lbs.

Local Trash and Recycling Ordinance Information:

- ❖ **Curb Side Pick-up:** Trash and Recycling receptacles may be set curbside after 9:00pm on the day preceding the scheduled day of collection and no later than 6:00am on the scheduled day of collection.
- ❖ **Recycling:** No plastic bags permitted in recycling containers. *Cardboard not in a container must be broken down and compacted into another box, not loosely stacked.*
- ❖ **Residential Properties:** Limited to (2) two 95-gallon cans with manufacturer constructed lift bar or (6) 32 gallon receptacles when fully loaded, not weighing more than 50lbs each.
- ❖ **Commercial Properties:** limited to (3) three 95-gallon cans with manufacturer constructed lift bar. **Commercial Properties are responsible for their trash removal in excess of this limit.**
- ❖ **Hotels/Motels:** limited to (1) one 95-gallon can with manufacturer constructed lift bar for every (4) rental units. **Effective May 1, 2023 Commercial, Hotel and Motel Properties may not use 32 gallon trash receptacles. Hotels/Hotels are responsible for their trash removal in excess of this limit.**
- ❖ **No Collection Holidays:** There will be no trash or recycling collection on the following holidays: **New Year's Day – Thanksgiving Day – Christmas Day.** If regular collection day falls on these holidays, collection will occur on the day immediately following the holiday.
- ❖ **Bulk-Trash:** Bulk trash pick-up is for residential properties only. Bulk trash pick-up occurs on the last standard trash pick-up day of each month for each zone excluding July & August. No mattresses and items over 75lbs. Do not put bulk trash items out on Thursday, Friday or Saturday.
- ❖ **Bulk Trash Permits:** Residents requesting additional bulk trash collection must first pay a fee at the Municipal Clerk's Office and schedule the pick-up through the Department of Public Works. The responsibility for removal of bulky items at any times other than as provided in this section shall be that of the property owner or occupant.
