
RPL Course and equivalencies

Centre Checklist

As we receive many requests from FREC® Learners, either seeking to attend a shortened FREC®3 course or claiming direct entry onto FREC®4 due to their prior learning, we have carried out comprehensive mapping against both regulated qualifications and unregulated courses (for emergency services first responders). This guidance provides clarification on the:

- 1. regulated qualifications we accept so that Learners can attend a 2-day FREC®3 RPL course, which covers the knowledge and skills not contained within that qualification.*
- 2. unregulated casualty care/first responder courses we accept so that Learners can attend a 2-day FREC®3 RPL course*
- 3. regulated qualifications and roles/courses we recognise as FREC®3 equivalents that allows direct entry onto FREC®4

*Important note: All Learners must have completed their course/qualification within 24 months of the FREC®3 course start date and are still required to complete all FREC®3 assessments.

It is the centres responsibility to conduct the initial mapping, once they have fully completed this document with appropriate evidence, it will then be reviewed by Qualsafe. For Centres claiming RPL on behalf of Individuals wanting courses and/or qualifications recognised that do not appear in this document, Qualsafe Awards charge a fee of £20 +VAT per hour to review (reviews are likely to take a minimum of 3 hours).

- Qualsafe/FutureQuals Level 3 Certificate in Ambulance Patient Care: Urgent Care Services (RQF)

Approved role/course recognition for direct entry to Level 4 FREC

- Emergency Care Assistant/Ambulance Support Worker (Emergency) with 12 months operational frontline experience currently employed by an Ambulance Service NHS Trust
- Army Combat Medical Technician Class 1, Royal Air Force Medic, Royal Navy or Royal Marine Medical Assistant (must be currently serving or has left the military medic role within the last 24 months)
- HSE Offshore Medic who has previously been a Combat Medical Technician Class 1, Royal Air Force Medic, Royal Navy or Royal Marine – Medical Assistant
- St John Ambulance Emergency Ambulance Crew (must be current and have evidence of CPD)

Important note: NMC Registered Nurses with CPD activity covering the content of FREC®3 wanting direct entry to FREC®4 are required to undertake FREC®3 assessments (as a minimum) prior to registering on a FREC®4 course.

Student Paramedics who have completed Year 1 successfully are able to attend a FREC®3 2-day RPL course. Student Paramedics who have completed Year 1 and 2 are able to directly enter FREC®4. Learners must evidence their achievement by supplying Centres with a written confirmation from an HCPC approved education provider.
