MassDEP is mailing to Don Ouellette's attention the attached letter, regarding final approval of the replacement well for Baldwin Pond #1.

Enclosed with the letter is a revised sampling schedule to reflect that the Baldwin Pond WTP is now the entry point sampling location for the Baldwin Pond Wells. The attached file called 3315000c.pdf is a copy of the revised sampling schedule. Please give this to Don Millette and anyone else who needs a copy.

Please note that the sampling schedule requires two quarters of SOC testing in 2010 at the WTP. This is because Baldwin Pond #1 and #2 were off-line in 2009 when you were collecting SOC samples at the other wells. The Chamberlain Well was also not tested for SOC in 2009; if it goes back on-line this year, you should get SOC samples from the well.

On March 25, 2002, the Massachusetts Department of Environmental Protection (MassDEP) approved construction of a replacement well for the Town of Wayland's Baldwin Pond Well No. 1. The iron level in the well had increased dramatically in the previous few years, and video inspection suggested that the well screen might be deteriorating. When the Town prepared to place the replacement well on-line, it found that the iron level in the well water was much higher than it had been during 2001 testing of the well. The well therefore remained off-line until the recent completion of the Baldwin Pond Water Treatment Facility.

The Baldwin Pond Water Treatment Facility was approved to be activated on February 23, 2010. Baldwin Pond No. 1 Replacement Well is now approved for permanent, regular use as a source of public water supply.

Baldwin Pond No. 1 Replacement Well is a 12" x 18" gravel packed well 52 feet deep, screened from 42 to 52 feet below the ground surface. The well is equipped with a submersible pump with a design rate of 525 gallons per minute (gpm) at 75 feet of head, with a 15 horsepower motor. The well water will receive treatment at the Baldwin Pond Water Treatment Facility via ozone for pre-oxidation, polyaluminum chloride for coagulation, sodium bisulfite for ozone removal, membrane ultrafiltration for iron and manganese removal, potassium hydroxide for pH adjustment, sodium hypochlorite for disinfection, and sodium fluoride for fluoridation.

MassDEP has assigned a **Source Identification Number** of 3315000-09G to Baldwin Pond No. 1 Replacement Well. The **approved daily volume** for the combined pumping from Baldwin Pond No. 1 Replacement Well and Baldwin Pond Wells Nos. 2 and 3 is 1.51 million gallons per day (MGD). This is equivalent to a combined **approved pumping rate** of 1,050 gpm.

With the activation of the replacement well, the original Baldwin Pond Well No. 1 (3315000-01G) is now considered by MassDEP to be abandoned. Baldwin Pond Well No. 1 will no longer be considered a source of public water supply. The well has been physically decommissioned.

A revised schedule of required water quality sampling for Wayland is attached, which reflects that the Baldwin Pond Water Treatment Facility is now the entry point sample location for the three Baldwin Pond Wells. Because Baldwin Pond Wells Nos. 1 and 2 were off-line in 2009, when the Town collected its Synthetic Organic Chemical (SOC) samples for the 2008-2010 compliance period, the sampling schedule includes two quarters of SOC sampling in 2010 at the treatment facility.
