Going full circle....

Today we gave a gift to Avera@Home Hospice in memory of Jim Russell.

It was important that this memorial be something significant - something that reflected the importance of the gift Mr. Russell gave Countryside in September of 1980.

By all appearances, Mr. Russell's gift was very simple and somewhat disappointing - a rejection actually - when approached about the possibility of starting a hospice program at the hospital. The answer was no, but if we wanted to pursue the idea we could have office space, lights, phone and a \$2,000 stipend.

Basically, Mr. Russell sent us to the community for support - the very best thing that could have happened. We worked harder, involved more people and grew stronger - we did every fundraiser known to man, built our volunteer base, developed a thrift store, started a home health and palliative care program and served hundreds of hospice patients.

We never charged for any services provided. The community stepped up to the plate time and again and we continued to grow. By the time we joined the hospital in 1995 our roots were firm.

Fast forward to 2021 and our discussion about a memorial gift for Mr. Russell. We struggled to find just the right idea.

Then, Jennifer Finley from Avera @ Home Hospice attended the August board meeting. Jennifer talked about the number of patients they were caring for and how hard the team was working to keep them all safe and comfortable at home - she talked about making extra visits and bringing in food and other ways that the team goes above and beyond. Part of this care made possible by the monthly donation you provide through Countryside, but mostly made possible by the caring spirit of the team.

After Jennifer left the meeting it was clear what the memorial gift for Jim should be. A donation in his memory to Avera@Home Hospice would bring things full circle.

The discussion began about the amount of the gift - finally someone suggested \$2,000 - the same amount we received in 1980. That seemed perfect - until someone wondered what that \$2,000 would be worth today.

The answer - \$6,626.09 - in memory of Jim to be used to supplement nursing and aide care for hospice patients. A great return on a gift that changed the course of Countryside.

P.S. As I wrote the last sentence I had to smile - my dad's name was Jim - it was through his hospice stay that I developed my passion for end of life care - I think of him and his caregiver's often - how they came into my parents' apartment, kicked off their shoes and settled in for a visit while my mother rested or went to the store. They became family in a matter of weeks, supporting my mom and dad in Florida and my brother and me thousands of miles away. It's not their technical skill that I remember, but their compassion and humor, their ability to listen and teach, their gift of presence.

I know this connection with hospice providers is not a unique experience - just last week a gentleman came to the office with a donation - he talked about the care that his wife received from Avera@Home Hospice - for a moment he struggled with the right words to describe his appreciation and finally settled for "those ladies are something else". Indeed they are...

Thanks, Jim.

When is a garage more than a garage?

We have a great garage attached to St. Benedict's Guest House. It is used to store a few household and yard items but it is mostly empty. At the other end of the house we have a small conference room, it was originally a chapel and worked perfectly for the sisters. Now, however, it is a tight squeeze for board meetings, support groups and educational programs.

We are going to convert the mostly empty garage into a conference/education space. We will use it for Countryside activities and also open it up for use by the community. It will be small enough for Bible study and book club groups and large enough for educational programs, board meetings and staff retreats. We hope it will be functional, accessible and welcoming. We hope it will be well used.

Disenfranchised grief – providing support for losses we didn't even know existed

We have had many deaths in our community - good, kind people who are gone too soon - families and friends have circled the wagons, providing food and comfort, coming together to share memories and wonderful stories, tears and laughter.

The death of a loved one is recognized as a time of grief and mourning. But what about the other losses that people are experiencing that do not seem to garner that same type of support?

20 plus years ago, Ken Doka coined the phrase *disenfranchised grief* to address the losses in our life that are important to us but may not seem important to others. These losses may not be openly acknowledged, socially sanctioned - or publicly mourned.

Doka goes on to say that disenfranchised grief is not black-or-white. You and I may experience the same loss and in your social situation the loss is openly acknowledged whereas in my social situation, among my friends and community, it is not. A few examples of disenfranchised grief include:

1. A death by suicide
2. A death by drug overdose
3. Death of a pet
4. Infertility
5. Loss of a home
6. Grieving someone you didn't know well
7. The death of a sibling
8. Grief that people think has gone on 'too long'
9. Death of the partner in an extra-marital affair.
10. Loss of a job
11. Divorce
12. Moving/loss of community
13. Grieving someone you can't remember (ex. a parent who died when you were an infant)
14. Death of an ex-spouse, ex-in-law
15. Miscarriage and stillbirth
16. Estrangement from family
17. Loss of meaningful objects/belongings
18. Loss of language, culture, and tradition
19. Loss of hopes and dreams for the future
20. Grief following an abortion
21. Learning a secret/finding out a person wasn't who you thought they were
22. Grieving a loved one with Alzheimer's or dementia
23. Grieving a loved one with a substance use disorder
24. Grieving someone who is dealing with a mental illness
25. Loss of physical health
26. Loss of independence
27. The death of a co-worker
28. The death of a patient or client
29. Loss of 'lifestyle' (losing financial means, getting clean from drugs/alcohol)
30. Death of a step-child/step-parent
31. Loss of identity or sense of self
32. Grieving a close friend
33. Parenting/custody battles
34. Feeling abandoned by a parent who is involved but distant after a divorce

(This is only a partial list - Doka listed 64 examples of disenfranchised grief in his original article)

World, state, national events and COVID have provided us with many opportunities for disenfranchised grief – children and adults are struggling with changes in their school, work and home life. We grieve for people who have died that we have never met - we struggle with the loss of dreams and plans - we have days when we are frustrated and angry.

Even happy events may have an element of loss - your child going off to school or getting married, a promotion, retirement, or a new home may produce feelings of sadness that take us by surprise and are difficult to explain. So many relationships and events in our life cause happiness and sorrow - hopefully you will find someone who can listen to your story without judgement - and then will listen to your story again until you no longer have the need to tell it -
