If a cancellation is made by the member or guest within 7 days of the party date, the 50% non-refundable deposit will be forfeited. If an event is cancelled by the JLAAC for unexpected circumstances, a full refund will be made. A check will be sent within 10 business days or the credit card can be refunded.
