We do not encourage/permit videos or photos of our classes by outside parties however we will not disrupt the class/workshop or event to stop this from happening. Due to being in a public space, this third party is breaking no rules/laws. However, we will do our best to discourage this third party from filming, taking photos etc...

Should a member of the class wish to film a short section for personal use we ask that you obtain permission from anyone who may appear in the film and do not disrupt the class by doing so.
