



Tournament & George Gervin Facility Rules

- All who enter must agree to: TOURNAMENT AND FACILITY RULES.
- ALL TEAMS MUST BE READY TO PLAY 1ST MATCH IN CASE OF FORFEIT OR CHANGES
- NO GUM! NO FOOD OR DRINKS (except water) in the GYM, **NO coffee & TUMBLERS** either!
- \$5 for 12 & under, \$10 for 12 & over. CASH ONLY
- Some concessions provided; CHAIRS ALLOWED but MUST NOT be on the court floor. T
- The facility doors will open approximately 30 minutes prior to the start of the first match. (TO HELP AVOID OVERCROWDING) wristbands will be sold ahead of time to help with lines.
- No yelling at the referees, coaches, other parents, scorekeepers, or line judges at any time.
- Any unattended items left in the facility, or your vehicles will not be the responsibility of the facility.
- If anyone does not comply with these rules you will be asked to leave.
- Warm-up will be 2-4-4; 2 minutes shared, 4 min serving team, 4 min receiving team, serve within your 4.
- R1 OFFICIALS PROVIDED BUT the Officiating team must provide 2nd Referee, bookkeeper, score-flipper, libero tracker and 2 lines judges. **No food or phones at the score table. Coaches, please use both sides of line up sheets for all your matches, use both sides of libero tracker.**
- Please have your players & parents clear their bench & sitting area of trash after each match.
- Park in designated spaces, your car will be towed if parked illegally.
- 4 team pool matches, 1st & 2nd set to 25, cap 27, win by 2. If necessary, a 3rd match will be played to 15, cap 17, win by 2. Tie breakers are decided by USAV Rules. 2-way tie – head-to-head; 3-way tie - match %, set %, then point %. 1st place medals in each pool, no playoffs. Last match
- 5 team pool matches, only 2 sets to 25, cap at 27, 1 place medals in each pool, no playoffs. **DUE TO TIME CONSTRAINTS, THE LAST 2 MATCHES OF THE 5 TEAM POOL MIGHT NOT BE PLAYED.**
- **Do not leave** until checking out with the tournament director about final officiating assignments. The championship match will be officiated by the ORIGINAL 4th seed of that pool unless they are in the championship match, then either the ORIGINAL 1st or 2nd seed will officiate, whichever has officiated only once during pool play.
