

Game-On Sports Tournament & SA FORCE Facility Rules

- Force Sport Center is located at 7218 N Loop 1604 E, SA TX 78233
- All who enter, must agree to: TOURNAMENT AND FACILITY RULES.
- <u>**NEW**NO PARKING ON DIRT/UNPAVED AREAS ANYMORE, YOU MUST PARK ON PAVEMENT</u> or you will be TOWED!
- ALL TEAMS MUST BE READY TO PLAY 1ST MATCH IN CASE OF FORFEIT OR CHANGES
- NO GUM! NO FOOD OR DRINKS (except water) in the GYM, especially coffee & TUMBLERS
- \$3 for 12 & under, \$5 for 12 & over.
- Concessions provided. PERSONAL CHAIRS <u>NOT</u> ALLOWED. Bleacher chair support OK.
- The facility doors will open approx 30 minutes prior to the start of the first match, for setup & so the previous tournament can clear out spectators, adjust nets, and clean up.
- No yelling at the referees, scorekeepers or line judges at any time.
- Any unattended items left in the facility or vehicles will not be the responsibility of the facility.
- If anyone does not comply with these rules you will be asked to leave.
- Warm-up 2-4-4; 2 min shared, 4 min serving team, 4 min receiving team, serve within your 4.
- R1 OFFICIALS PROVIDED BUT Officiating team must provide 2nd Referee, book-keeper, score-keeper, libero tracker and 2 lines judges. No food or phones are allowed at the scorer table.
- Please have your players & parents clear their bench & sitting area of trash after each match to allow others the opportunity to sit down and watch their daughter play. Do unto others...
- Park in designated parking spaces, your car will be towed if parked illegally.
- Pools 1 & 2 will COMPETE for 1st place medals after a CROSSOVER MATCH. Pools 3 & 4 will have pool play and then bracket play. Original 4th seed teams in Pools 1 & 2 (SA Elite 131 Navy & SA Legacy 14-1) will officiate the championship on their court. (Unless they are in the championship, then the 1st or 2nd seeded team will officiate.) All matches, 1st & 2nd set to 25, win by 2. If necessary, a 3rd match will play to 15, win by 2. Tie breakers are decided by USAV Rules. 2 way tie head to head; 3 way tie match %, set %, then point %.
- Do not leave until checking out with the tournament director about final officiating assignments.
