

### UL 2218 Class 4 Impact-Resistance Test<sup>3</sup>

A 2" steel ball is dropped twice from a 20-foot height onto various target locations to evaluate the shingles' ability to withstand the impact.



Results on a standard shingle: Evidence of visible ruptures or cracks through the shingle immediately after impact.



Results on a Class 4 shingle: No evidence of ruptures or cracks through the shingle immediately after impact.



The perfect neutral color, Slate complements a broad range of hues and works well with sage, cream, ivory, and beige.





Hickory is the most neutral of shades and works wonderfully with blues, grays, whites, yellow, gold, sage, and green.






