Kennedy Ave- Phase 1 and 2 started in 2025 to be completed in 2027 Phase 3 to start in 2027-2029 and Phase 4 to start in 2029-2031

A question was asked about the 911 system in Dyer and Schererville.

Dyer uses the county 911 system on the weekends- this is County dispatch and they notify Dyer Emergency personal of any issues and route them to the area. They may not be familiar with the area you are in or any explanation of the area.

Schererville - Cedar Lake came together and use South County Dispatch- This is local and they dispatch emergency personal.

Financial report by Finance Team- Ralph Flens

Ralph went over the Finance report and explained we were in good shape, however the community is aging and with that will come some future expenses for the trees, sprinkler system and other possible issues.

Discussion- Ralph said suggested a \$5.00 increase in monthly dues. Dues will be \$175.00 per month. Increase will Start on 01-01-2026

Vote on 2026 Budget - Board motion to approve 2026 budget, motion was second, motion approved.

Resource Management report - Kevin and Suzanne  
Certification of Quorum - Kevin stated that we did make the Quorum and this is an official meeting.
