This AGREEMENT was read and signed on the date of _____, 2023

TERMS AND CONDITIONS:

1. The writer **Slummy Charms** hereby assigns, transfers and delivers an original written composition to the publisher, _____. Writers' credit of lyrics associated with song requests is solely to be addressed to **Slummy Charms**.
2. The writer, **Slummy Charms**, promises to send the completed song (hook, verse, bridge, intro and outro) to the email provided through submission of contract and proof of payment within *SEVEN days* of approved paperwork and an audio file of song inquiry.
3. The writer, **Slummy Charms**, promises *TWO REWRITES* in the case of said publisher, _____, request of a revision *AFTER* receiving a completed copy of lyrics and audio file (within seven days of approved paperwork and an audio file of song inquiry) with no fee added.
4. The writer, **Slummy Charms**, requires a \$75 payment prior to song turnaround. Valid payment methods are PayPal and Cashapp only. Without confirmation of approved paperwork (proof of payment and contract signed and dated) the agreement is null.
5. The writer, **Slummy Charms**, has the right to deny the work of any artist. If publisher, _____, request gets denied by writer they will

receive an email notifying their paperwork has been denied and proof of a \$70 refund.
Refunds will be sent through the same payment method the publisher paid through.

6. The writer, **Slummy Charms**, requires a 5% fee of royalties of song through any music platform. This includes but is not limited to Apple Music, YouTube, Spotify, iHeart Radio, Deezer, Instagram, Facebook, club rotations, iTunes, Amazon, Shazam, ASCAP, BMI, TikTok, Pandora, and/or SESAC.

8. I, _____, publisher of the requested song(s) inquiry understand that failure to comply to the terms and conditions of the above will result to a minimum fine of \$500 and reimbursement of lost royalties.
