I hereby represent that I am the legal owner of the dog described above (the 'Dog') to be enrolled in 'THE BALANCED BARK.'

I hereby release THE BALANCED BARK, its employees, owners, representatives, and agents from all liability which I, the Dog, any third party or their pet may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from my actions or failure to act, the Dog's actions or the Dog's attendance and participation at The Balanced Bark.

I hereby agree to indemnify and hold harmless THE BALANCED BARK, its employees, owners, representatives, and agents from all claims, or claims by myself or any third party accompanying me to a function of THE BALANCED BARK, or while attending the premises thereof, as a result of any action or failure to act by me or the Dog.

I hereby represent that the Dog is of good health (I.e.: No diarrhea, no vomiting, not lethargic, clear eyes and ears, no cough) and has not been ill with any known contagious diseases within the last thirty days.

I recognize that the health of the Dog is my personal responsibility. I hereby represent that all required vaccinations for the Dog are up to date and will continue to remain so for as long as the Dog attends The Balanced Bark. I will also promptly provide proof of all booster vaccinations to The Balanced Bark. **Initial:**

I further understand and agree that in admitting the Dog, THE BALANCED BARK has relied on my representation that the Dog is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other dog.

I understand that by bringing the Dog to an open concept care facility means that they will be playing and interacting with other dogs. Minor cuts or scratches are inevitable, and though the dogs are carefully always supervised, and the staff and owners do their utmost to keep them safe, there is no warranty or representation by The Balanced Bark that a more serious incident (scuffles, fighting, even death) will not occur. I accept the risk of any such more serious incident happening. **Initial:** _____

I understand that THE BALANCED BARK prefers the Dog to wear a properly fitting Martingale collar. I understand that THE BALANCED BARK will use an anti slip device for potty breaks and pack walks on the Dog if there is no Martingale collar present. The only time a Martingale and/or anti slip device will not be used is if there is written verification by a veterinarian that a medical condition exists that a tightening collar cannot be used. (Ie: Collapsed trachea). Initial: _____

I further understand and agree that THE BALANCED BARK and their caregivers will not be liable for any problems that might develop with the Dog, including but not limited to sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.

I understand I am solely responsible for any harm caused by the Dog to another dog while they are at THE BALANCED BARK. If for any reason, THE BALANCED BARK is unable to further care for the Dog, I must have an emergency contact be available to pick up and care for the Dog.

The hours of operation of THE BALANCED BARK are 6:30am to 6:30pm ("Closing Time") Monday to Friday. I agree that management retains the right to amend the hours of operation at any time. I

understand that I must pay in full for care and services rendered before the Dog is released from THE BALANCED BARK into my custody.

****I agree to pick up the Dog prior to Closing Time. It is hereby acknowledged that should I fail to pick up the Dog before Closing Time, a late fee will be charged (\$1 per minute for a maximum of 30 minutes) and needs to be paid in cash upon arrival at THE BALANCED BARK and before the Dog is released from THE BALANCED BARK into my custody. In the case that the Dog is not picked up prior to the maximum of 30 minutes, I agree that the Manager will then take the Dog to the Manager's residence, and I agree to pay a surcharge of \$75.00 regardless of when I pick up the Dog. The \$75.00 to be paid in cash upon my arrival and before the Dog is released.** Initial:** _____

I understand that I am to walk the Dog in and out of the facility on a leash, and in a safe and expedient manner.

****Daycare reservations MUST be made and confirmed. Multiple dates can be scheduled at the same time. Reservation cancellations or reschedules must be made, and confirmed, 12 hours prior to scheduled daycare reservation or a missed reservation fee of \$20.00 will apply. Scheduled daycare drop-offs later than 10am will be cancelled and charged a missed reservation fee.** Initial:** _____

THE BALANCED BARK reserves the right to permanently remove a dog from its daycare at anytime.

****THE BALANCED BARK daycare fees are non-refundable and non-transferable.**** Initial: _____
