

Freedom of Choice Student Center Homeschool Summer Enrollment Agreement

Welcome to the family of Freedom of Choice Student Center Homeschool (FCSCH). This Enrollment Agreement is intended to make our Homeschool's relationship with You clear, and to explain some of the School's policies that will govern that relationship. If You have any questions or concerns that are not answered or addressed in this Enrollment Agreement, please contact Dan or Kathy Granite for further information. FCSCH partners with you to provide educational services and support for every student. This agreement ("Agreement") is between Freedom of Choice Student Center Homeschool ("FCSCH") and the Parent/Guardian/Student(s). This Agreement includes all Services. By activating the Service, You acknowledge that You have read and understood, and You agree, to the terms of this Agreement. Freedom of Choice Student Center Homeschool may change the terms of the Agreement from time to time. Please initial where indicated.

Enrollment Payment Policy: ____ Initial

Deposit: A \$50 non-refundable deposit per child will hold your child's spot. The deposit is due at the time of enrollment. We will apply the deposit to the cost of the chosen session. The remaining balance must be paid in full no later than seven (7) days before the beginning of each chosen session. Enrollments made inside of the 7-day window will be charged a \$25 late fee which will not go toward the cost of the session.

Students may not attend until the full payment is submitted. If paying by check, the funds must have cleared the bank before the student can attend. There will be a \$25.00 service fee on all returned checks.

Cancellation Policy: ____ Initial

If you enroll in a program and your plans change, you can receive a full refund, less the non-refundable \$50 deposit. To receive a full refund, minus the \$50 deposit, the cancellation request must be received no later than 4:00 pm (PST) seven (7) calendar days before the enrolled start date. Participants who do not contact us to cancel by 4:00 pm (PST) seven (7) calendar days before the start date, will not receive a refund. By submitting your payment, you are agreeing to this policy.

Parent Responsibility: ____ Initial

To ensure a successful and rewarding learning program, each parent is an essential part of his or her child's education. Parents are responsible for the following:

- Contact Your student's teacher(s) as you feel necessary.
- Contact Director Dan and your child's teacher via text and/or email if the child will be late to or absent.
- Notify the Freedom of Choice Student Center Homeschool of any address, phone

number and email changes or leave of absence.

- To be on time. Parents are to ensure that their students arrive prior to 9:00 am to avoid class interruption and disruption of the learning environment. The school says the Pledge of Allegiance to the flag promptly at 9:00 am.
- Pets of any kind are not allowed in the school building or courtyard.
 - If a pet is in the parking lot, the Freedom of Choice Student Center Homeschool is not responsible for any pet, pet activities, pet issues. The pet owner has full responsibility for the pet even when outside of the Freedom of Choice Student Center Homeschool property.

What is Included: ____ Initial

All summer sessions, with the exception of a one-time supply fee if indicated, include costs for curriculum, teacher and administrative services.

Information Sharing and Disclosure

Mandatory Arbitration: ____ Initial

Any dispute or claim between Customer and Freedom of Choice Student Center Homeschool arising out of or relating to the Service or Device provided in connection with this Agreement shall be resolved by arbitration before a single arbitrator administered by the American Arbitration Association in San Diego County, California. Judgment on the award rendered by the arbitrators must be entered in the state and federal courts of San Diego County, California. All claims shall be arbitrated individually and the Customer will not bring, or join a punitive or certified class action to arbitration or seek to consolidate or bring previously consolidated claims in arbitration. The arbitrator shall have no authority to award punitive damages. Customer acknowledges that this arbitration provision constitutes a waiver of any right to a jury trial.

Miscellaneous

Attendance: ____ Initial

Freedom of Choice Student Center Homeschool expects the student to be on time and in attendance each scheduled day. Should there be a time when the student will be absent or arriving late (more than 15 minutes), the parent is asked to either email and/or text the home teacher and FCSCH Director. Should there be plans for long-term absences (three days or more), the parent is asked to inform the home teacher and FCSCH Director at least one week prior.

Student Discipline: ____ Initial

ALL students, family members, and staff are expected to follow Freedom of Choice's civility policies. These policies include: treating ALL members of the school community with respect (this includes: students, parents, family members, staff, and any guest speakers). Students are expected to be in their classrooms when the class is scheduled to begin. Students are to behave respectfully toward staff and students at all times. Students are expected to respect other students' opinions, work, and to wait until they are called upon to respond and to NEVER make fun of another student's work or comments.

There will be NO tolerance for bullying, fighting, defacing school property, or violating academic integrity policies. Students are expected to keep their hands to themselves. Weapons of any kind are strictly prohibited. This includes pocket knives or any other object that resembles a weapon, real or fake. Violations of any of the "Homeschool's" policies will be addressed with the student and depending on the violation, the parents, subsequent violations will result in

suspension from classes. If the behavior persists, students may be expelled from the school. Enrollment payments will not be refunded.

Treatment of the Campus & Campus surroundings: ____ Initial

Students are to treat the campus grounds with respect. There is to be no destruction of the property whatsoever. No throwing of food on the ground or littering. Treat our classrooms, carpet, desks, tables, chairs & tablecloths with respect! There is no tolerance for writing or adding stickers to desks or walls. Students are expected to pick up after themselves. Students are to be at a noise level that doesn't disturb other classes or others around them. They are expected to clean off their lunch area or areas where they have sat. Treat our plants & flowers with respect.

- Students & adults are to treat the bathrooms with respect. No clogging of toilets, sinks or making messes purposely. No use of toiletries for other reasons than what they are intended for or using mass amounts. There is no tolerance for writing or adding stickers to walls.
- If there is damage done to property on campus, parents will be expected to pay for such damage.

Behavioral Expectations: ____ Initial

- All members of the Freedom of Choice community must be respectful of each other at all times.
- Everyone has a voice but must take their turn when using it.
- We must keep our hands to ourselves.
- If the student is behaving inappropriately, the behavior will be addressed privately with the student.
- If these interventions do not change the student's behavior the result may include dismissal from the program with the parents forfeiting their tuition.
- There will be NO tolerance for drugs or being under the influence of drugs. Anyone exhibiting such behavior will be dismissed from the school.
- Sammy, the dog, will be in attendance most days. Please do not hold him, pick him up or pull on him. He loves everyone and you may pet him.
- Students are expected to arrive before the Pledge of Allegiance and be respectful of the Flag.

Cell Phone Policy: ____ Initial

- Cell phone use is not permitted during class time unless directed to do so by the teacher. Phones may NOT be used to check the time. If parents must contact their child, they should call or email the School Counselor or Director. One or both will be present at all times.
- Students will be asked to put away their phones, non-compliance will result in a call home.

Medical Emergencies: ____ Initial

I authorize the staff of FCSCCH to provide first aid and to secure emergency medical care for my child should it be necessary.

Family Marriages: ____ Initial

In regard to marriages which have been separated or terminated, both parties agree to communicate all pertinent school & class information between one another and to not hold FCSCCH responsible to inform each party individually.

I agree to supply any pertinent information regarding custody, visitation, or other related issues to the school and agree to hold harmless the school in attempting to uphold orders. If paperwork is not present, I also agree to hold harmless the school from issues regarding custody due to lack of information to uphold.

Severability: ____ Initial

If any provision of this Agreement is held to be invalid, void, or illegal by a court or arbitrator of competent jurisdiction, the same shall be deemed severable from the remainder of this Agreement and shall in no way affect, impair or invalidate the remaining provisions herein. If any provision shall be deemed invalid due to its scope or breadth, such provision shall be deemed valid to the extent of the scope or breadth permitted by law.

Participation in Freedom of Choice Student Center Homeschool is optional. Should You choose to enroll Your student in Freedom of Choice Student Center Homeschool, You and the Student must abide by this Agreement.
