



## **CONFISCATED FIREARMS TRANSFER AUTHORIZATION**

This Confiscated Firearms Transfer Authorization ("Authorization") is executed pursuant to the Memorandum of Understanding ("MOU") between **Guns 4 Good** ("G4G") and **[Law Enforcement Agency Name]** ("Agency").

### **1 - PURPOSE**

This Authorization documents the Agency's approval to release one or more firearms currently in its custody to Guns 4 Good's designated Federal Firearms Licensee ("FFL Partner") for lawful inspection, processing, and disposition in accordance with all applicable federal, state, and local laws.

This Authorization applies only to the firearms specifically identified below.

### **2 - LEGAL AUTHORITY FOR TRANSFER**

The Agency certifies that the firearms listed herein are eligible for transfer based on one or more of the following (check all that apply):

- Court Order
- Forfeiture Determination
- Administrative Release Authorization
- Destruction Diversion Program
- Prosecutorial Approval

### **3 - CUSTODY & TRANSFER CONDITIONS**

- The Agency retains custody and responsibility for the firearms until physical transfer to the designated FFL Partner is completed
- Guns 4 Good does not take possession, ownership, or control of the firearms at any time prior to FFL transfer
- Transfer shall occur **directly** from the Agency to the FFL Partner
- All transfers shall be conducted in compliance with ATF regulations and applicable law

### **4 - LIMITATIONS**

The Agency acknowledges that:

- Guns 4 Good does not act as a firearms dealer
- Guns 4 Good does not receive firearms directly from law enforcement
- All inspection, refurbishment, resale, or destruction determinations are performed exclusively by licensed FFL partners
- No valuation, resale price, or charitable allocation is guaranteed for any firearm

### **5 - LIABILITY & IMMUNITY**

Each Party remains responsible for its own acts and omissions.

Nothing in this Authorization constitutes:

- A waiver of sovereign immunity
- An assumption of liability by Guns 4 Good
- A modification of the underlying MOU
