Cory attended the Prescription Drug Abuse and Herion Summit in Atlanta. Prescription psychostimulants like Adderall, Vivance, Ritalin are being prescribed more, traded and sold. Meth trafficking, more coming from the southern boarder, is on the rise. Higher end crystal meth is on the rise in our area. New trend to mix Meth and Heroin called a "Goofball." 80% of neuro synapsis are established by the age of 3. 80% of drug addicts experience childhood trauma. An OD Map, overdose mapping across the U.S. monitored by High Intensity Drug Trafficking Areas, can be a good resource for law enforcement to monitor spikes in OD's and possible dangerous drug activity. The first lady spoke at the conference and spoke on how the neonatal abstinence syndrome is on the rise. The president indicated strong support of treatment courts.

Regarding the billboard initiative, Cory has the final artwork available. Number of overdose deaths has risen to 99 dead in the last 5 years. It will cost approximately \$3,800 for four billboard locations. The coalition will be paying \$500; the remaining will be paid by the SABG grant from HHS. The first billboard should be going up later this month.
