Petitioner's Request for Name Change and Restoration of Rights

To Whom it May Concern:

I am writing to assert my rights as a natural person, distinct from a legal person, to obtain a name decree in accordance with the law. As a living being with inherent rights and freedoms, I have the legal authority to change my name through the appropriate legal channels.

It is crucial to recognize the differentiation between a natural person, which refers to an individual as a human being, and a legal person, which typically refers to entities such as corporations, organizations, or other artificial entities created by law. As a natural person, I have the inherent right to self-determine my identity, including my name, and to seek legal recognition of such changes.

The law recognizes the autonomy and agency of natural persons to change their names for various reasons, including personal, cultural, or religious motivations. By exercising my rights as a natural person, I am seeking a name decree to reflect my true identity and personal circumstances, in alignment with legal and ethical principles.

Personal Background and Intent

The petitioner affirms that they have no felony convictions and is not seeking a name change to defraud creditors or for any other fraudulent purpose.

The petitioner's current legal name is represented in uppercase letters BROCK EDWARD O'KENNARD as designated by the state. The petitioner seeks to legally change their name to "lowercase name," reflecting the name given to them by their parents and restoring their identity as a natural person. This request aims to address issues arising from the misrepresentation of their name

under legal and civil doctrines.

The petitioner asserts that the use of "ALL CAPS" creates a mistaken identity under legal doctrines, such as idem sonans, which has led to undesirable situations, including:

- 1. **Roman Civil Law Implications**: The capitalization reflects "Capitis Diminutio Maxima," a concept denoting the highest loss of status and rights.
- 2. **Agent-Principal Confusion**: Misidentification of the petitioner as an agent or principal in legal and financial contexts has resulted in unintended liabilities.
- 3. **Parens Patriae Misapplication**: Erroneous classification of the petitioner as a ward under state guardianship.
- 4. **Volunteer Suretyship**: Imputed liabilities stemming from mistaken associations with third-party entities or estates bearing similar names.

The petitioner acknowledges the need for grace and forgiveness for any prior unintentional use of "ALL CAPS" and seeks relief from mistaken assumptions of liability, status, or obligation.

Legal and Equitable Relief Sought

The petitioner requests the court to:

- 1. **Grant the Name Change**: Recognize the petitioner's legal name as "lowercase name" to eliminate confusion and restore personal identity.
- 2. **Restore Fundamental Rights**: Protect the petitioner's rights as a natural person, including: Civilian due process of law without misnomers.
- o Autonomy to live in accordance with biblical and personal principles.
 - Defense against mistaken suretyship or misclassification as an agent for any state or foreign entities.
 - 3. **Safeguard Equitable Interests**: Reinstate the petitioner's rights to manage their own affairs, free from mistaken identities or legal impositions tied to "ALL CAPS."
 - 4. **Facilitate Record Updates**: Provide documentation enabling updates to identification records and notification to relevant parties of the name change.

Affirmation of Intent

The petitioner asserts their understanding of the legal procedures involved in a name change and commits to compliance with all requirements, including submission of documentation, payment of fees, and adherence to court directives. The petitioner's request aligns with their inherent rights as a natural person and seeks to rectify prior misunderstandings stemming from the misrepresentation of their identity.

The petitioner respectfully requests the court's understanding and support in granting the name change and associated relief, thereby upholding their dignity, autonomy, and fundamental rights as a living being.


