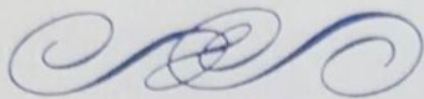

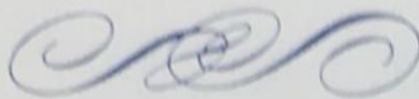

i: Relisha-Marie Beverly come in peace. i mistakenly addressed my first notice to Christina S. Stewart and assume the letter was forwarded to your office of State Registrar, however i am enclosing a copy with correction just to make sure.

In addition to notice to remove my private information from public record and requesting a way to operate using the CHILD and birth certificate without the liability i wish to address a few statutes and rules that govern the use of Federal Reserve Notes and the Federal Reserve System.

Fact: Federal Reserve Notes are not "money" as defined by the constitution they are "obligation of the United States"

Fact: i am not authorized to use Federal Reserve Notes as a non-citizen, non-resident, non-federal reserve Agent, non-federal reserve bank
