SUPPLEMENTARY DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR CHANAN ESTATES

1. The Developer hereby specifically annexes all that property described in the Plat of Chanan Estates, 1st Addition, according to the plat thereof as recorded in Plat Book 24 at Page 56 of the Public Records of Okaloosa County, Florida (the "Additional Property"), and subjects such Additional Property to the provisions of the Declaration. From the date of the recording of this Supplementary Declaration of Covenants, Conditions, Restrictions and Easements, the Additional Property shall be held, sold, occupied, transferred and mortgaged or otherwise encumbered pursuant to and subject to the covenants, conditions, restrictions and easements provided in the Declaration, which shall run with the title to such Additional Property and shall be binding upon all persons having any right, title, or interest in such Additional Property, their respective heirs, legal representatives, successors, successors-in-title, and assigns.
