SID Parking Committee requested a proposal regarding downtown parking, directional signage, wayfinding, and an alternative parking solution to what we currently have. No survey of this magnitude has ever been done. It is very Thorough and can help in developing SID's Strategic Plan, funding priorities and the budget. The board members received an Englewood Wayfinding & Parking Plan that was prepared for Englewood SID by Carol Rauscher and Richard Engel. The document included an Executive Summary, Solution Summary and Solutions Detail. See report for details.

Implement Parking Ordinance No 17-07

- Update posted street parking regulation signs
- Reprogram meters
- Reprogram mobile parking app

Implement Directional and Informational Signage

- Install basic parking directional signage for all off street parking including Dean Street Garage, Lots B, E, H & N, Veterans Park, City Hall.
- Install digital informational signage at 2-3 key inbound motorist locations

Clean Up and Modernize Dean Street Garage

- Better lighting, LED if the budget allows, otherwise install additional fixtures
- Clean bright painting of walls and ceilings
- Eliminate hiding spaces around stairwells, pay stations, etc.
- Simplify signage inside garage
- Fence or wall off the city permit spaces in the lower level
- Remove or reutilize abandoned PARCS cement islands

Phase 1 Parking Evaluation of Downtown Englewood done in 2015 by Level G Associates Parking Consultants made recommendations and should be reviewed.

Al Krull noted site noted amentias such as benches, trash cans and paver cross walks need to be addressed.
