- The term "**FACILITY**" means/applies to any permanent or temporary indoor or outdoor facility or premises owned, contracted, rented, or operated by BATTLELINE TACTICAL, Host Range, Private Facilities as applicable.

Outdoor training involves risks due to exposure to the elements, terrain, vegetation, flora, fauna, insects and weather. Guest understands and acknowledges that training activities may involve strenuous physical exertion and mental/emotional stress. Guest is solely responsible for determining whether guest is physically capable and suited for training before engaging in any training activity. Guest warrants that guest does not suffer from any physical impairment or medical condition and is not under the influence of any prescription medication which would impair guest's ability to safely participate in training or use the facility and equipment used in training.

## TRAINING COURSE SAFETY BRIEF AND RULES

### COURSE SAFETY BRIEF.

EVERYONE is a Range Safety! If you see or feel there is a safety issue or violation of any kind you can call cease fire, stop, help, or any other command to alert the designated range safety officer, instructor, staff, or fellow safety officer. Safety is everyone's responsibility!

As applicable to either indoor, outdoor, or any other training facilities/locations; be aware of all potential physical hazards, local wildlife; maintain a safe distance and avoid provoking any animals encountered. Stay vigilant of changing weather conditions, such as sudden storms or extreme temperatures, and take appropriate precautions. Navigate the terrain carefully, watching for uneven ground or obstacles that may pose tripping hazards. Inspect equipment thoroughly before use, ensuring proper functionality and safety measures. Additionally, be mindful of other hazards, including nearby activities or individuals, and communicate effectively to mitigate any potential risks. Your safety is our priority, so let's work together to ensure a successful and incident-free session on the range. – First Safety, Second **HAVE FUN!**

**RULES:** Failure to comply or violations of any rule may result in your removal from the course.

1. All standard firearms and weapons handling/use safety requirements and practices of Battleline Tactical, the Host Range, and in general practice/use apply at all times.
2. When handling firearms the top three rules to remember are (but are not limited to);
  - a. Weapons On Safe when moving and when not directly engaging a target or threat.
  - b. Weapon Pointed in a Safe Direction at ALL TIMES, No Flagging Personnel.
  - c. Finger Off Trigger when moving and when not directly engaging a target or threat.
3. All personnel present on the range or involved in course operations, including the range owner, staff, guest instructors, students, volunteers, and any authorized observers, cannot be under the influence of, or experiencing residual effects from, alcohol, illegal drugs, misused prescription or over-the-counter medications, or any other substances that could impair judgment, reaction time, coordination, or the safe handling of firearms, weapons systems, or negotiation of hazardous terrain and obstacles. Each individual is solely responsible for understanding how their prescribed or authorized medications may affect their physical and cognitive performance, particularly when operating under physical exertion, mental stress, fatigue, or extreme environmental conditions. Personnel who are uncertain of their ability to perform safely are required to remove themselves from training or operations.
4. Pay attention to and follow all instructions and commands given by the Instructor, Range Safety Officer, and Staff at all times. If you are getting conflicting information follow the lead instructor's commands for training and the range safety officer's commands for safety. If all else fails – STOP and get clarification as needed.
5. Stay Hydrated and Healthy. It is the individual's responsibility to stay hydrated and monitor their own medical and physical condition. Stop and Rest as needed and report any potential emergencies to the Range Safety Officer, Instructor, or nearest student/staff member. Report all injuries to an Instructor, Range Safety Officer, or Staff Member. NOTE: This includes after the day is complete. Take time to recover as needed before traveling.
6. DO NOT LEAVE the area without telling a fellow student, staff member, Range Safety Officer, or Instructor first while the course is ongoing.
7. Unless explicitly waived by the Host Range, all rules and requirements established by the Host Range shall take precedence over Battleline Tactical rules and requirements, unless they conflict with specific safety standards mandated by the course requirements and are more stringent.
8. All protective equipment required by Battleline, the Host Range, or facility/location, will be used as applicable for the specific equipment's purpose at all times.
9. It is the individual owner's responsibility to maintain security of his/hers weapons, gear, equipment, vehicles, etc. at all times. Battleline Tactical and Host Range personnel are NOT responsible for any lost, stolen, or damaged property.
10. HAVE FUN! Keep a good attitude and be open to learning new things or new ways of doing the same old things. We can be safe, train to the highest levels, and still have a good time! Training is better with a SMILE!
