EVENT INFORMATION:

Thank you for your interest in Hitchcock Good Ole Days Food Truck Cook-Off & Craft Fair, a fundraising activity for the Hitchcock Chamber of Commerce to be held on Saturday, November 21, 2020 at the Good Ole Day's Grounds in Hitchcock, Texas. Volunteers will be on site before and during the event to guide patrons, assist vendors, and assist in the logistics of the day. HCofC will provide solid waste disposal and security for the event.

Food tickets will be sold to the general public by the Hitchcock Chamber of Commerce for \$3 per ticket to be redeemed for a 4 oz. sample of the vendor's signature dish. All other proceeds received for regular sales are the vendors to keep. Only one ticket may be redeemed per 4 oz. signature dish.

HCofC will accept a limited number of vendors to appear at the event. The **entry fee** for each vendor is **\$50.00**. If you wish to participate in the **Food Truck Cook-Off**, an additional contest fee of **\$150 will apply**.

The Hitchcock Chamber of Commerce will select a panel of 5 individuals who will judge each signature dish between the hours of 12pm and 2pm and then determine a winner based on the following criteria: taste, presentation, originality, and food truck design. A public opinion winner will be judged by the Food Tickets turned in to the Judges by the public throughout the day.

The vendor must provide a 4 oz. sample for each of the 5 judges, at their own expense. The grand prize for the overall best food truck will be \$500 cash. Second place will be awarded \$300 cash and third place will be awarded \$200 cash. A Public Opinion Award will be given to the voted on winner in that category.

All food vendor applications are due by **November 14, 2020**. Any applications received after the deadline will have a \$10 late fee.

The Hitchcock Chamber of Commerce will sell alcoholic beverages, soft drinks and water.

Vendors will **NOT** be allowed to sale alcoholic beverages, soft drinks or water. They may however sale, tea, coffee or lemonades.

Vendors must possess a valid Temporary Food Service Permit or you must apply for a Temporary Food Service Permit (\$75.00). Visit www.gchd.org/food to fill out and electronically submit food permit, or call 409-938-2411 for more information.

Vendors must arrive on Saturday, November 21, 2020 between the hours of 7:00am - 9:00am. No food trucks will allowed to enter the premises after 9:30am. Failure to arrive within the above time slots will result in disqualification from the event. Vendors must be ready for service by 10:00am on the day of the event and must continue to serve until approximately 5:00pm. No Vendor's vehicles will be allowed at their spot prior to 5 pm.

Refunds

Should the event be canceled by a change in the Governor's Executive Order, State Guidelines or Local Officials guidelines pertaining to the COVID-19 pandemic a full refund will be given. Refunds will not be given for any other reason other than cancellation of the event by the **Hitchcock Chamber of Commerce**.

The Hitchcock Chamber of Commerce does have Mayoral approval to host this event.

The HCofC does ask that each vendor follow local and state safety guidelines related to COVID-19. We will supply sanitation stations to the public, but vendors are responsible for supplying their own at the event. Should any vendor be found not in compliance with state and local guidelines they will be asked to close immediately with out refund. We trust everyone to be responsible and most importantly to have fun.
