- Offering benefits not with the intention to influence decisions illegitimately or gain an illegal advantage.

FAIR COMPETITION

We strictly prohibits anti-competitive agreements. We require our business partners to be committed to free and fair competition and to observe applicable laws, in particular competition and anti-trust legislation.

EXPORT CONTROL
