Insurance Requirements

The Organization shall procure and maintain for the duration of the Agreement, insurance against claims for injuries to persons or damage to property that may arise from or in connection with the use of the Premises.

The Organization shall provide a certificate of insurance evidencing:

General Liability insurance covering premises, products-completed operations and contractual liability. The Port of Manchester shall be named as an additional insured on the Organization's General Liability insurance policy. The General Liability insurance shall be written with limits no less than \$1,000,000 each occurrence, \$1,000,000 general aggregate.

The insurance policy shall contain, or be endorsed to contain that the Organization's insurance coverage shall be primary insurance as respect to the Port of Manchester. Any insurance, self-insurance, or insurance pool coverage maintained by the Port of Manchester shall be excess of the Organization's insurance and shall not contribute with it.

The Organization shall provide a certificate of insurance evidencing the required insurance before using the Premises.

Insurance is to be placed with insurers with a current A.M. Best rating of not less than A.
