WHEREAS, to clarify the meaning of "single-family" in Section XXXII of the aforementioned Declaration of Covenants, the first line of Section XXXII shall read "All mobile home property shall be for single-family occupancy, family being described as legal or blood relations, with no more than six (6) residents per unit as described by Florida Law for mobile homes. Exceptions to this may be voted upon by the Association's Board of Directors." The remainder of Section XXXII remains the same.
