MINOR RELEASE, WAIVER OF LIABILITY, NON-COMPETE & INDEMNITY AGREEMENT

READ CAREFULLY – THIS IS A RELEASE

I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE Professional Miniature Bull Riders Association, its officers, agents, employees, participants, rodeo association sanctioning organization or my subdivision thereof, arena operator, arena owner, officials, any persons in restricted area, promoters, sponsors, advertisers, owners lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose therein referred to as "Releases," from all liability to the undersigned, personal representatives, assigns, heirs and next of kin for any and all loss of damage and any claim or any demon on account of injury to the participant, including, but not limited to, death whether cause by negligence of the "Releases," or otherwise while the minor is in or upon the restricted are and/or competing, officiating, observing, working for or for any purpose in the event. The "restricted area" is defined as the arena, chutes, staging areas, approaches thereto and all walkways, concessions, and other area appurtenant to any such area where any activity related to the event shall take place. I hereby agree to allow the PMBR to utilize any photography or videography for marketing and promotion purposes.
