### Facts about Reverse-transcription polymerase chain reaction (RT-PCR)

- The RT-PCR Test is **NOT** a test for infection!
  - The RT-PCR detects RNA, not infectious virus.
  - The RT-PCR test by itself *cannot distinguish* between lifeless viral debris and viruses capable of reproducing.
  - The RT-PCR test proper use in medical diagnostics is to verify suspected causes of symptomatic illness. Reference: Doctor Flemming & Doctor Mercola
- Important points to understand about RT-PCR tests.
  - Cycle Threshold (Ct): is the number of cycles a RT-PCR test is run. Each cycle duplicates the sample by a factor of 2.
  - Symptom onset of test (STT): the number of days after the test that the subject developed COVID symptoms.
  - Live Virus: Samples that demonstrated viral growth in the lab.
- Excerpt from Study: <u>There was no growth in samples with a Ct > 24 or STT > 8 days.</u>

# Facts about COVID Testing Process

- Two types of RT-PCR tests available for COVID:
  - *Qualitative* = Test is run to the full number of permitted cycles <u>THEN</u> tested for a positive or negative result. This is the cheaper and far more common test in use. Known as "There or Not" test.
  - *Quantitative* = PCR cycles are run checking each cycle until a positive result or the maximum permitted cycles are reached. This is the more expensive test, usually only available upon request, and out of pocket payment is most often required. Most often run only after a positive <u>Qualitative</u> test has been completed.
- Neither test includes a follow up for onset of symptoms.
- The *ratio* of Qualitative/Quantitative tests reported in case results are unknown.
- Average Positive Result from Quantitative tests is a Ct = 26.2
- PCR Qualitative test cycles when testing unvaccinated individuals = 35 Ct 40 Ct
- This certainly puts the rate of false positives **WELLABOVE** 50%, and some experts estimate false positive rates as high as 70%.

# Symptomless risk of spreading infection

• Study of the claim of asymptomatic carriers showed that it was built from *conjecture* of the possibility that someone with an active infection of sufficient size to infect another person during the "Incubation Period" prior the onset of illness could be obtained. When this was put to the test, the data showed this conjecture to be incorrect as published in one of the worlds leading peer review publications.



# Protection Gene Therapy Provides

- CDC and Mainstream Media admit: Doctor Parks in Official testimony:
  - Indicates that the mRNA Gene Therapy cannot stop infection or the spread of infection because it wasn't designed to do that.
  - CDC indicates that the Gene Therapy MAY reduce symptoms for the original Variant, but provides no protection against the Delta Variant.




#### VAERS

- Established in 1990, the Vaccine Adverse Event Reporting System (VAERS) is a national early warning system to detect possible safety problems in U.S.-licensed vaccines. It is an outgrowth of the National Childhood Vaccine Injury Act of 1986 (NCVIA), VAERS is co-managed by the Centers for Disease Control and Prevention (CDC) and the U.S. Food and Drug Administration (FDA). VAERS accepts and analyzes reports of adverse events (possible side effects) after a person has received a vaccination. Anyone can report an adverse event to VAERS. Healthcare professionals are required to report certain adverse events and vaccine manufacturers are required to report all adverse events that come to their attention.
- By monitoring such events, VAERS helps to identify any important new safety concerns that otherwise may not come to light before licensure.


- Thousands of unacknowledged injured World Wide can be viewed: <u>HERE</u>

More then 55,000 events classified as serious (life threating) and more then 8000 permanent injuries.





# FDA Approval

- Emergency Use Authorization (EUA): Approved for EUA is NOT FDA Approved. An EUA is normally only issued under very specific conditions, however these conditions didn't actually exist since highly effective anti-viral treatments for COVID were developed.
- Comirnaty was licensed but is not available: This Gene Therapy has a specific legal distinction from the EUA version, in addition to other undisclosed ingredients. Legally it cannot be used interchangeably as has been implied.
- Comirnaty Data missing: Medical Experts noted that the information sheets for this product are missing many of the key items required by the FDA such as complete listing of ingredients, and animal & human trial results. Without complete information Informed Consent *CANNOT* take place.

#### Some Terms to Review

• Coercion: "the use of express or implied threats of violence or reprisal (such as discharge from employment) or other intimidating behavior that puts a person in immediate fear of the consequences in order to compel that person to act against his or her will." Actual violence, threats of violence, or other acts of pressure may constitute coercion if they're used to subvert an individual's **free will or consent.**https://www.findlaw.com/criminal/criminal-charges/what-is-coercion-law.html

• Voluntary: Free; without compulsion or solicitation. Without consideration; without valuable consideration; gratuitous. Voluntary courtesy. A voluntary act of kindness; an act of kindness performed by one man towards another, of the free will and inclination of the doer, without any previous request or promise of reward made by him who is the object of the courtesy: from which the law will not imply a promise of remuneration.

# Nuremburg Code and US Law

- The universal right of *Informed Consent* to medical interventions has been recognized in US law since at least 1914.
  - New York Court of Appeals established the right to informed consent in 1914: <u>Schloendorff v. Society of New York Hospital 105 N.E. 92, 93 N.Y. (1914)</u>.
  - "Every human being of adult years and sound mind has a right to determine what shall be done with his own body"
- US Supreme Court decision in 1987 *US v. Stanley, 483 YS 669 (1987)*
- Excerpt from the dissenting opinion joined by justices Marshal, Stevens & O'Connor:
  - "The United States Military Tribunal established the Nuremberg Code as a standard against which applies to all citizens—soldiers as well as civilians."
  - "Its first principle was: "The voluntary consent of the human subject is absolutely essential".

# The Nuremberg Code Article 6

#### • Voluntary Consent (Point 1):

- "to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion". Subjecting individuals to useless masking and ineffective testing until they attest to accepting an experimental treatment is coercion.
- "Comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision." *Issuance of blank vaccine inserts, obfuscation of ingredients as "proprietary" make it impossible for individuals or medical professionals to make an enlightened decision.*
- Animal Studies (Point 2): The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.
  - Normally 3-6 years of studies before moving to human testing.
  - "Very limited" animal studies were conducted on the specific Gene Therapy for COVID 19, the results of which are NOT available as is normal for any other medication.
- (Point 4): The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
- (Point 10) During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

### Executive Orders – Laws or Not

- Executive Orders Law? No they are not.
- They may carry the "weight of law" but *ONLY* insofar as:
  - They're directed to a department or other government entity under the Constitutional authority of the President of the United States of America... AND the orders themselves do not violate the Constitution itself or any local, state, or federal statute which lawfully derives its authority from the Constitution.
  - Article II, Section 3 Clause 5: "he shall take Care that the Laws be faithfully executed" indicates that the President may neither breach federal law nor order their subordinates to do so.
- In Summary,
  - Executive orders only apply to members of the Executive Branch, not to private citizens.
  - Executive orders cannot breach or violate law and the Constitution.

#### Summary

- RT-PCR as a medical diagnostic tool was only meant to aid in diagnosis of symptomatic patients, otherwise it provides unacceptable levels of false positives
- As published in Nature, one of the worlds leading peer reviewed publications, there is no indication that asymptomatic spread of COVID can occur.
- COVID 19 Gene Therapies are designed to reduce symptoms and do not prevent contraction or spreading of infection. May even cause an increase spreading of illness due to reduced symptoms when active infections are present.
- The CDCs own system know as VAERS reports disturbingly high numbers of adverse affects among those that have been subjected to one of the COVID 19 Gene Therapies.
- US and International Law prohibits the use of *Coercion* to force someone to do accept medical interventions against their will AND the *individual* who executes these actions are held *personally* responsible, regardless where or who the direction came from.
- Bodily Integrity is a Basic Human Right as detailed in the *Nuremburg Code*.
- What would you call humans who are denied the basic right to chose what medical procedures and experiments they are subjected to?
