## **TERMS AND CONDITIONS**

### **DEPOSITS AND PAYMENTS**

Once I have confirmed my availability, a security deposit must be sent (electronically) in order to reserve the session requested. This deposit is deducted from the total cost of the session. Please note this deposit in non refundable and is non-transferrable. Deposits must be sent by Zelle.

On the day of the contracted event, the balance due must be paid before the artist(s) leaves. Dates will not be reserved without deposit.

\*If for any reason the artist cancels at any time or is unable to perform artist's duties, the deposit will be fully refunded by the same electronic method

#### TRAVEL FEES

Travel fees will vary depending on the location. A travel fee considering gas, mileage and tolls acquired while in route to the desired location, will be added to the remaining balance. Any venue fees acquired upon arrival to the venue will be added to the remaining balance due, such as valet service, metered parking fees and resort fees. If there is more than (1) artist providing service, the travel fee as well as venue fees will be multiplied by the number of artist attending the event

#### **CANCELATIONS**

Reimbursements will depend on the time between the date of the cancellation request and the date of the event. If a client choose to cancel 90 days before the event, a full refund will be dispersed. If a client choose to cancel 60 days before the event, a partial refund of 50% of the deposit amount will be reimbursed.

If a client choose to cancel 30 days before the event, a partial refund of 20% of the deposit amount will be reimbursed. If a client cancel any time after the 30 days before the event, client forfeits all payments.

\*Processing may take up to 48 hours.

#### **TERMS AND CONDITIONS**

#### **TARDIES AND DELAYS**

When late, we have no problem on working with you, as long as it is during your contracted/scheduled time slot. The tardy makeup application or hair styling will not exceed your scheduled time and will not run into the following client's session.

A late fee of \$25 will be charged if delay is beyond 20 minutes of the start time. If the client arrives 30 min late of the start time and the artist needs to go to the next client, the balance due must be pay without exceptions.

#### HAIR AND MAKEUP RECOMMENDATIONS

Please arrive with hair fully dry before your appointment. The client must wash it the day prior to the event, or in case that the hair is extremely greasy, it must be washed and dried the same day a few hours before the appointment.

Also, the client must come with a clean face (wash it with a cleanser) in order to speed up the makeup process. If the client has any allergy, please let us know.

#### **SOCIAL MEDIA**

Photos taken on your wedding day may be used as examples of my work for future clients to view. Your photographer will receive proper credit for their work. You agree to me using these photos, as well as give consent to using your professional photos on my portfolio and social media.

### **LIABILITY**

All makeup products and brushes are kept sanitary. All products are sanitized between every makeup application.

Any skin condition, allergies or sensitivities should be reported prior to the application. Client agrees to release the artist from liability for any skin complications due to allergic reactions.

### **EARLY APPOINTMENT**

An additional \$35 fee will be added to services for booked appointments reserved between the hours of 4:00 am and 8:00 am.
