3. As a condition of displaying their cars, exhibitors agree to leave their cars in place from 9:00 a.m. to 3:00 p.m. on 11/14/2026.
4. Only qualified and **registered** vehicles will be guaranteed a parking place in the exhibitors' area.
5. Canopies, banners or other signage relating to exhibitor cars or other interests are not allowed, with the exception of a descriptive placard, which may be positioned directly in front of the car or on the dash. "For Sale" signs are prohibited unless written permission is received from the show organizers in advance of the show.
6. All exhibitors are required to have full insurance policies in effect for their display vehicles.
7. No soliciting is allowed including, but not limited to, handing out of any material, brochures or offerings of any kind without the written permission of the show organizers in advance of the show.
