

Communications: Chair Alexa Noel had asked that Jeanne Rhinehart give the report that The Mid-American was distributed to 253 email addresses on October 31, 2015. The editors, Susan and Charles Wilson report that each time they add new names and a few more emails are bounced back. Please ensure that all the email addresses are kept up to date and notify them if they are changed. Discussions are underway concerning the website, what is possible and not possible to add or expand. If you have suggestions for going forward, to please email the Communications Chair, Alexa Noel. We thank Brian Spitler for his continuing work. We are also discussing the addition of a Facebook Page. It is a great tool for reaching new people but does not replace the website functions. For the past three years, we have sponsored an Essay Contest. It has not been a great success. We will re-evaluate. (Note: this has been started again for the Fall MAOC meeting 2016.

Motion to accept the report passed.

Conservation: Chair Russ Vernon, reported



from the Committee's Friday evening meeting that Jack Shumaker, Doug Martin and Bill Morrison were in attendance. He expected the same requests for this year as the past year for grants of \$400 to the Cleveland

Botanic Garden, the Marjorie McNeely Conservatory and the Wheeler-Thanhauser Orchid Collection and Species Bank at Ball State University. The McNeely Conservatory had wanted to use the money to virus test the plants, but it is preferred by the committee to add species to their collection with the money. It was further suggested that it work with the university or a local entity to do the testing. Friends of Como, had donated \$8,000 to do testing and the conservatory staff created an isolated growing area for those testing positive. Their goal is to become the first virus free collection in the USA.

The Greater Cincinnati Orchid Society continues to map out native orchid species in a state preserve, hand pollinate flowers and harvest small quantities of seed to grow and repopulate existing colonies and establish new colonies in the Cranberry Bog State Preserve.

The Niagara Frontier Orchid Society has acquired Cypripedium species plants, planted them in pots and will plant in the spring. Doug Martin suggested that the MAOC establish communications with the North American Conservation Center associated with the Smithsonian. There might be ways to support projects and other conservation efforts in our region. He will contact them.

Russ reported that the Wheeler Thanhauser Orchid Collection and Species Bank has received funding from an outside source to establish a collection of all slipper orchid species available in trade. The fund has exceeded \$16,000. This will be the Betty Kindle Orchid Collection. The committee received approval for the grants and any new requests will be considered in Buffalo, at the Fall MAOC meeting.

Doug Martin reported at the same time on the North American Orchid Conservation Council that has been watching with groups observing the culture, seed banking, and restoration projects and to check out the Smithsonian Orchids on the web. Beth reported that there are Orchidgami projects on the site, where you can print out little paper orchids, cut them out, and put them together. This has a site for donations as well. Motion to accept the report passed.

# **<u>Constitution and By-laws:</u>** No report at this time.

**Education and Research:** Doug Hartong reported that he and Cheryl Erins met on Friday night and that while there are projects to be worked on, there is no progress report at this time as we are unable to add things to the website. As reported, discussions are underway as to what to do with the website.

**<u>Historica</u>**: Aileen Garrison reported for Chair Lois Holmes and gave a little history lesson of the MAOC down memory lane. Lois will chair the Essay Contest and provide for judges of essays, in hopes of resurrecting interest. The topic for the Fall meeting is: Why I would like to know more about (orchid person, place or thing). Must be 500 words or less, Deadline will be October 1, 2016. Report Accepted

She reported that the Krauski glass wall plaque was to be raffled off, but that a very generous donation from Hermann and Dorothy Pigors had just been made of another plaque by the same company, so that we would draw two winners from the tickets which netted \$550. The winners were Jim Newsome and Mary Beth Mansour. Motion to accept the report passed.

#### **REPORT TO MID-AMERICA AFFILIATED ORCHID SOCIETIES**

The site that host societies Greater Cincinnati Orchid Society and Miami Valley Orchid Society chose for the spring meeting of the Mid-America Orchid Congress was remarkable. A National Historic Landmark hotel, the Hilton Cincinnati Netherland Plaza, in the heart of downtown Cincinnati served both as our conference hotel and also the site of the orchid show and sale. All of the Congress activities were on the 4<sup>th</sup> floor, which featured the Rosewood ballroom on one side and the Rookwood ballroom on the other. Both Rosewood (Roseville) and Rookwood were famous ceramics firms in the 19<sup>th</sup> and 20<sup>th</sup> centuries in Ohio, and their surviving pieces are now collectors' items. (Employees of the Rookwood firm now own it: it is in Cincinnati.) Pillars in the Rosewood ballroom were

surrounded by the pink Rosewood tiles, and the green Rookwood tiles surrounded the pillars in the Rookwood ballroom. This hotel opened in 1931 and featured French Art Deco décor. Today the hotel has 624 guest rooms and the only five-star restaurant in Ohio-named "Orchids"! That restaurant is breathtaking in its décor soaring three stories high and elaborately decorated in art décor style. The food and service are truly worthy of a five -star rating. Many Congress registrants ate there on Saturday evening-the host societies chose not to have the traditional banquet but, instead, invited registrants to sample Orchids or another of the numerous, excellent restaurants available within a short walk of the Hotel.

On Saturday morning, Head Judge Ken Mettler organized the 26 judges and an equivalent number of clerks into eight teams to judge the 23 exhibits and approximately 370 plants. Eleven orchids were identified for AOS judging and three of them received four awards (details appear in the minutes of the Sunday morning Business Meeting elsewhere in this newsletter.)

Eighty persons registered for the Congress. Leon Glicenstein Ph.D., the AOS Conservation Speaker, presented an interesting lecture "The Cloud Forest of Costa Rica." His enthusiasm and appreciation of Costa Rica were contagious as he discussed the beauty of Costa Rica. Dr. Glicenstein discovered many of the 1,600 orchid species in Costa Rica. Among his discoveries are Telipogon glicenstenii and Lepanthes glicensteinii.

Francisco Miranda, taxonomist, owner of Miranda Orchids, Haines City, Fl discussed "The Genus Laelia in Brazil." Francisco guided the travelogue through Brazil, associating the native laelias with cultural requirements.

Gustavo A. Aguirre shared his knowledge acquired through 45 years of "Growing Colombian Pleurothallidinae." The emphasis was identifying & duplicating cultural needs as Pleurothallids grow in nature.

#### AFFILIATED SOCIETIES BREAKFAST

<u>DISCUSSION:</u> "How the electronic age can empower your society communications," created some lively suggestions:

WEBSITES: Most societies have websites: All websites should include email contact information for your society. Some societies may not have a website due to cost. However: Orchid Mall, Google and many other sites can assist building and host sites for societies at no charge. They don't have to be fancy. Important feature of MAOC website: access show schedule & intergeneric list. Check for up-dated AOS website.

FACEBOOK: Advertise show, easy communication, more socially active

Younger people prefer to access information through Facebook

Effective way to get new members; Easy to share pictures.
