 - IN 1 MILE AT THE LIGHT THE ROAD CURVES TO THE RIGHT AND THEN AT THE NEXT LIGHT CURVES TO THE LEFT AROUND THE LAKE AND TURNS INTO RT 21.
- GO NORTH 3 MILES TO RT 25.
 - THIS IS A BIG INTERSECTION WITH LIGHT & 2 GAS STATIONS (one closed) ON THE FAR CORNERS.
- TURN RIGHT ON TO RT 25 EASTBOUND
- GO EAST ¼ MILE TO A TRAFFIC LIGHT
 - THERE IS A BP GAS STATION ON THE LEFT.
