Treasurer's Report:

Balance: \$3,155.55

Expenses: \$10.08 (computer expenses)

- Jane is creating new income categories for each year's dues in our Quicken bookkeeping software. Occasionally, a few members attempt to renew their membership in April or May because Austin Pastel Society's renewals are due then. That makes financial reporting for each fiscal year difficult, since we have had only one generic "Dues" category. Historically, we have selected dates AFTER the last meeting of the year to report on dues received for the new year. Notes in each transaction can be clarifying, but are not searchable or included in report parameters. Though we still recommend renewals be made AFTER the last meeting of the prior year, these more-specific categories provide some flexibility without compromising our financial records.
