

**WINTER PARK ALPINE ARTAFFAIR
JULY 11 – 12, 2020**

Winter Park Alpine ArtAffair cordially invites you to apply to the 47th annual exhibition and sale of fine arts & fine crafts. The Alpine ArtAffair is a friendly, outdoor not-for-profit show, staffed by volunteers who strive to provide an enjoyable experience for artists & visitors alike.

Location: Winter Park Alpine ArtAffair will be held in the Rendezvous Event Center in Hideaway Park, in the heart of downtown Winter Park, Colorado. Because this is a municipal park, **no driving to assigned booth space will be allowed and no tent stakes are allowed.**

Eligibility: Winter Park Alpine ArtAffair is open to artists who will be present to exhibit work of their own concept, design and execution. The show is juried to ensure overall quality and balance, with preference given to work reflecting the greatest degree of originality, creativity, and craftsmanship. **No manufactured, commercial, imported or kit work will be considered or permitted.** Only merchandise of artists selected by the jury will be allowed. Approximately 65 artists will be accepted. Each artist participant **must** attend his/her booth and is responsible for insurance and sale of his/her artwork. No commission on sales is charged.

Exhibit Space: Assigned booth space is 10'x10'. Artists will provide their own equipment, display, and tent. **Each tent leg requires 40lbs minimum weight for safety purposes (wind).** All parts of the display must fit within the assigned area. Park grounds are grass and/or concrete and **no tent stakes are allowed.** Conditions vary from flat to slightly sloping. Because the show is held outside, suitable protection from sun, wind and rain is suggested. There is no rain date. Booth space may be shared if both artists have paid jury fees and have been accepted. Double booth space (\$380) may be purchased if available.

Digital Photos: Submit **four digital** photos, including a booth image if possible, in jpg. format via email (**maximum 1MB**). Please do not send samples. Digital photos should be a good representation of your fine art. Email to: alpineartaffair@yahoo.com

IMPORTANT INFORMATION: The Town of Winter Park requires each vendor to obtain a 2020 annual business license. **The yearly fee is \$60.** If accepted to the Alpine ArtAffair, each artist **MUST** purchase the \$60 license from the Town of Winter Park before July 10, 2020. However, if your license from the 2019 show does not expire until the end of July, 2020, you will not need to purchase a new license. We recommend waiting until July 1st – 10th to purchase this license because it will not expire until July 31, 2021. Please contact the Town of Winter Park with any questions: (www.wpgov.com)

Sales Tax: Artists will be responsible for collecting **11.2%** sales tax (Municipal, State, County). Tax forms will be supplied upon check-in and taxes collected Sunday afternoon by ArtAffair officials.

Selection and Notification: Applications are juried by an Alpine ArtAffair committee. Entries will not be considered if they do not comply with the application rules. Artists are considered solely on the merits of work displayed in photos. Prior years' participation in the Winter Park Alpine ArtAffair does not ensure acceptance. The notification to artists will be postmarked by May 15, 2020. The decisions of the jury are final.

2020 Fees:

Jury Fee -- \$20 per applicant (non-refundable). If sharing a booth, both artists must be juried

Booth Fee -- \$190 per space (deposited upon acceptance). Booth fee is non-refundable after June 1, 2020.
