## RE: AMERICAN FREEDOM & INDIVIDUAL RIGHTS UNDER LAW

We are writing this letter to you not just on behalf of all Miami-Dade County residents, but on behalf of our fellow citizens and residents in the surrounding counties of Monroe, Collier, Broward and Palm Beach. In fact, we are writing this letter on behalf of our fellow citizens and residents in all counties throughout the entire state of Florida, as well as on behalf of our fellow citizens and residents in all counties throughout all states within the USA. Hence this letter will be made available in generic form for anybody who wishes to print it out and send it to their local municipal leaders and/or governor. We will also be sending this letter to the Governor of Florida.

We delivered a letter to your office on July 7, 2020 that was written on July 4, 2020 and addressed to Attorney General Bill Barr and the Department of Justice. That letter was sent to Attorney General Bill Barr and the Department of Justice for essentially the same reason that this letter is being written and sent to you.

You have no right, authority or power to mandate that any citizen of the United States of America wear or attach anything at all to any part of their face, head or body. Neither does any other local municipal government leader or governor have the right to make any such mandate, rule, regulation, ordinance or law. To do so is a blatant violation of the United States Constitution and Civil Rights. Moreover, and perhaps more importantly, it is a violation of the Americans with Disabilities Act, Title III, which is a Federal Law. That law protects US Citizens in a "broad" and far-reaching manner without the ability or intent to define what an individual's mental, psycho-emotional and/or physical condition(s) or impairment(s) might be, which rightfully precludes and exempts millions of people from being required and forced to cover their head and/or face.

## There is no state or local municipal government mandate, rule, regulation, ordinance or law that can supersede and override ANY Federal Law.

As was indicated in our letter to Attorney General Bill Barr and the Department of Justice, the Americans with Disabilities Act, Title III, exists in the manner and form that it exists precisely because of the fact that there is an infinite number of possibilities that may constitute the mental, psycho-emotional and/or physical condition(s) or impairment(s) of individual human beings. You do not know if a child had abusive parents that wrapped a scarf around their mouth and face and placed a bag over their head and stuck him or her in a dark closet for an hour or two because they did not want to hear the child crying, screaming and carrying on. You do not know if a woman was mugged and had a sack put over her head while she was raped. You do not know if a person had a drowning experience. You do not know if a person is claustrophobic

and, if so, why. You do not know if a person has a weak diaphragm or weak lungs that has never been diagnosed as such. You do not know if a person is suffering from asthma, COPD or any other respiratory ailment - whether it has been diagnosed or not. You do not know anything at all about the mental, psycho-emotional and/or physical condition(s) or impairment(s) of countless millions of Americans. Under Federal Law, neither you nor anyone else has the right to ask any given person what their mental, psycho-emotional and/or physical health condition(s) or impairment(s) might be.

It is thoughtless, inconsiderate, self-absorbed and dangerous for any person in any position of power to think that they can make a mandate, rule, regulation, ordinance or law requiring and forcing another human being to wear or attach any apparatus or device to their face, head or body. That is all aside from the fact that any such government leader should have the common sense and reason to know that it is also a violation of the United States Constitution, Bill of Rights and Civil Rights.

We demand that you and every other municipal leader and governor immediately cease and desist from making any such mandate, rule, regulation, ordinance or law. Our next step will be to file suit in Federal Court to ensure that no city, county or state can continue making such blatant violations of the Rights of US Citizens and legal Residents under the United States Constitution, Bill of Rights and Federal Civil Rights Laws.
