I am writing to you as an American citizen age 54 , father of 22years and husband of 23 years.. I am pleading for justice to be served for the tortured killing of my father, Murray B. Cohen, age 71. My father was poisoned, tortured and murdered on the floor of his home on Siesta Key in Sarasota, Florida on January 13, 2003. The Sarasota Sheriff's Office (SSO) is the law enforcement agency with jurisdiction in this matter. I simply did a public records request for a copy of the 911 recording made by my fathers wife of three weeks who claimed that she discovered my father passed away in a peaceful afternoon nap. Upon listening to that recording, my life changed forever. I was shocked and horrified when I heard my father cry out for an ambulance and shortly after that in the middle of being instructed on how to do CPR, his wife dropped the phone and then I heard her yelling at my father to give up.

SSO made a grave investigative mistake when they classified my fathers death as natural. I brought the extreme mistake to their attention. Instead of fixing it, they attacked me, smeared me and chose to destroy evidence and obstruct justice to cover up their mistake. I have been condemned to spend the rest of my life churning my wheels fighting for justice to be served. I have been forced to do my own investigation into my father's death. So far, I have lost ten years of my working and family life. Not one law enforcement officer or elected official in Florida has the courage to rise to the call for justice to be served.

A year ago, the head of the Jacksonville FBI office, James Casey retired after 30 years of service and went into private practice. He was in charge of 250 agents and all FBI investigations of North Florida. Mr. Casey also serve on George W. Bush's national security counsel at the White House for two years. About eight months ago, he was retained to investigate my father's death. In a 48 page report, with six volumes of evidence, Mr. Casey found probable cause that my father was victim of a cold blooded murder committed by his wife of three weeks. Mr. Casey also stated, "Mr. Esdale was mostly right about everything he discovered which proved his father was murdered". Mr. Casey also stated in his investigative reported that he listened to the recording and he could hear my father's wife yelling at him to give up. His report was delivered to Rick Scott's legal department and they determined it to be nothing new. To date, Governor Rick Scott refuses to get involved or answer letters for pleas of justice with silence.

The unique barrier blocking justice in this case is the fact that acting law enforcement committed destruction of evidence and obstruction of justice. They were given cover by Florida Department of Law Enforcement by the Sarasota and Tampa FBI. It has reached

the point of no return and there is no way that these agencies are going to admit to committing an extreme threat to our entire legal system and an extreme violation of the public trust in this case. Mr. Casey told me directly that nobody in the State of Florida or the FBI going to voluntarily fix this injustice unless someone above them makes them.

The other unique factor in this case is the Jeb Bush factor. He was the Governor at the time of my father's death. Governor Bush turned down all requests for a special prosecutor to be appointed and order FDLE to do a full blown investigation. The evidence in our case cried out for a full blown investigative of the Sarasota Sheriff's actions. After I managed to obtain media coverage and with a public relations disaster brewing, Governor personally ordered a review of the falsified existing case file manufactured by the Sarasota Sheriff's office. This review was the kiss of death for any chance of justice to be served. When Governor Bush ordered the review, he made a conscious choice of picking political loyalty over rule of law. After Jeb Bush left office, his firewall was left behind and to this day the same people that were in Jeb Bush's legal office work in Governor Scott's legal office. With the help of personnel in the Sarasota and Tampa FBI office, the system has been gamed and rigged so justice will never be served in my father's murder.

The shield protecting everyone involved in this case who committed wrong doing is the transcript generated by an analyst at the FBI Quantico Laboratory. Personnel at the Sarasota Sheriff's Office took the pristine crystal clear digital DVD copy of the 911 call involving my father's death and deliberately altered it by transferring onto an analog cassette tape. Multiple generations were then copied from the cassette tape until the background was degraded so bad, that my father's murder can no longer be detected. SSO then sent this poor quality version to the FBI lab and requested an examination and transcript. They knew that the analyst at the laboratory was not going to hear my father being murdered in the background. Unfortunately, they did this after I already had obtained a clear enough copy to discover my father being murdered in the back ground. All in a nut shell, this transcript has protected law enforcement from getting caught and justice being served in this case. Law enforcement involved in this case have used my outrage of their cover up and being forced to live with a recording of my father being tortured and murdered with no help from law enforcement.

SSO and FDLE has created false documentation and information to slander me and guarantee no one will listen to or help me. They have classified my relentless fight for justice as a danger and potential threat. It is clear that when I was classified as a potential danger or threat, it enabled the Patriot Act to be used to eavesdrop in on my confidential conversations with my attorneys to stay one step ahead of us to make sure that the knowledge of obstruction of justice by law enforcement in this case never sees the light of day.

Besides the 911 recording, I discovered the poison that his wife gave him on January 13, 2003, that brought on the chain of events which lead to his death. It is called Corazol solution. It was inventoried by law enforcement officials at the death scene. It was listed on their documentation as a prescribed medication given by my father's doctor. Two

years after my father's death, I researched what Corazol Solution is. I was shocked when I learned that Corazol is lethal to humans and is banned in the United States by the FDA for human consumption. In my discovery of what Corazol was, I learned that it is used in European laboratories on rats to induce respiratory failure in research studies of epilepsy. I also learned that every test animal given Corazol died. Shortly after my discovery, my father's doctor was contacted and asked if he prescribed Corazol solution to my father. He said he did not know what Corazol was nor did he prescribe it. My father died an unattended death with a lethal substance found at the death scene, and against Florida law, no autopsy was performed..

The former Sarasota County Medical Examiner, William Anderson is the person who signed my father's death certificate. After reviewing all of my investigative discoveries, Dr. Anderson has admitted that he made a mistake in not doing an autopsy on my father's body at the time of his death. He has spent years trying to fix his mistake and allow my family justice and closure. Dr. Anderson is the only one involved in this case who has tried to do the right thing. He has made numerous sworn affidavits and also wrote a letter directly to the Governor of Florida stating that he made a mistake and the state of Florida needs to exhume my father's body and determine the true cause of death. His letter was never answered by the Governor's office. The current medical examiner, Russell Vega replaced Dr. Anderson shortly after my father's death, and has opposed Dr. Anderson's position that my father's body needs to be exhumed and given an autopsy to this day. The wife of three weeks has spent \$140,000 over the years fighting exhumation of her husband's body.

Ten months after my father's death, I realized that the Sarasota Sheriff's office had no intention of arresting my father's killer and fixing their mistake. I quickly realized that the only chance I had in the world to obtain justice at that juncture was to try to get my story in the media and put public pressure on the Sarasota Sheriffs Office to do the right thing. My family and I made the mistake of believing the promises from the Fox network when they promised to cover our story until all legitimate questions were answered or justice was served. Instead, When Governor Bush got involved, our coverage suddenly stopped. Mr. Casey stated in his investigative report that FDLE's involvement was doomed from the start. There is a world of difference between a review of an existing file designed to cover up obstruction of justice and a full blown investigation.

In 2005, I managed to get my story covered by the Sarasota Herald Tribune which is the newspaper for Sarasota county. In all five articles written by the Herald Tribune, they were all riddled with false information and inaccuracies. The title of article four was "Governor Bush Sparks Review of the Cohen Case". In this article, the Florida Department of Law Enforcement's spokes person downplayed the significance of the review ordered by the Governor. He further stated that the review was not an investigation. In the final article written by the Herald Tribune, they titled it, "FDLE Finds No Evidence of Murder". In the beginning paragraph of the article, the reporter started the sentence by saying, "After a four month investigation". He knew that there was no investigation. It was designed so the reader was left thinking that FDLE did an

investigation and no evidence of murder was found. Once again, a media outlet helped the wrongdoers off the hook and deceive the public.

I gained the attention of a news reporter from the Orlando Sentinel in 2007 and I told him how SSO altered the 911 recording. He called the Sarasota Sheriff's Office on July 16th, 2007 and made a public records request for access to the original 911 call which was on the hard drive. On July 18, 2007, the sheriff's counsel obtained an ex parte court order allowing him to destroy the hard drive. On July 20th, the hard drive was picked up and pulverized by an outside contractor. The Orlando Sentinel newspaper had the Sarasota Sheriff's Office backed in a corner. The attorneys for the Orlando Sentinel newspaper sent the Sheriff's Counsel, Kurt Hoffman a letter informing them of their violation of the Florida Public Records Request laws when they deliberately destroyed the hard drive. This letter was copied to the Sarasota State Attorney's office, the Governor's office and the Attorney General. It was never followed up with a lawsuit or complaint. The Orlando Sentinel let the Sarasota Sheriff's Office off the hook. Their actions was a disservice to the public and shows how corrupt public officials escape accountability and leaves the public in the dark.

Govern Rick Scott has violated his sworn oath as Chief Executive of the State of Florida by denying justice to my family. He refuses to fix Jeb Bush's mistake. My family should not be denied justice because Jeb Bush might want to run for president one day and does not want Florida seniors to know that his mistake in this case allowed a cold blooded killer of a Florida senior to escape justice.

Our fight for justice has cost us dearly. I have lost of thousands of hours of working time and quality time with my family. Our life savings retirement account gone and credit destroyed. My fathers killer also got away with stealing my son's college fund, leaving him \$38,000 in college loans.

This extreme American injustice has obliterated our constitutional right to the pursuit of happiness. After a ten year unsuccessful fight for justice and every single remedy to obtain it blocked, my family and I are asking you to please step in and request that the justice department examine the correct 911 recording and conduct an investigation into the violations of my father's civil rights.

After fighting for over ten years, we are justified in turning to you as the Chief Executive of our Government who has the power to facilitate correcting this extreme American injustice. Please set me free and let this be the last fathers day that I will have to wake up the saddest father in America.
