We submit this letter to you at the request of Steven J. Esdale, who has asked us to write to you to confirm that earlier this year, my company, GaideCom, Inc., received a compact disc from the Sarasota County Sheriff's Office

We received the aforementioned compact disc from the Sarasota County Sheriff's Office on February 7, 2004. Embodied in the compact disc is a recording of the 911 call made by Maria Cohen on January 13, 2003. Prior to receiving the compact disc, I was informed by Detective Chris Hallisey (via a telephone conversation in January 2004) that the compact disc we would receive would contain the 911 call, broken into six segments. He explained to me that this segmentation had been performed by the Federal Bureau of Investigation upon their receipt of the recording from the Sarasota County Sheriff's Office. The compact disc had no label affixed to it; it merely had the word "copy" handwritten on its face.

The compact disc we received from the Sarasota County Sheriff's Office was accompanied by a letter, dated January 30, 2004, and was printed on the Sheriff's Office's official letterhead. The stationary appears to be genuine and is not a photocopy. The letter was sent by Sheriff William Balkwill and Paul Richard, Sergeant, Criminal Investigation Bureau.
