May 2024 Update on MPW Water Project

Greetings friends and neighbors of our beautiful Ventura Villas Community. To begin this report, I am much more than pleased to inform you that the Community's new water line installation and meter relocation project is making great progress and in a timely manner as well. Mother Nature has been a good friend throughout the project by providing Anson Construction crews with very good weather since the project started months ago.

As I continue to attend the weekly onsite project meetings with representatives of the MPW Engineering staff and the job foreman of Anson Construction Company, I am delighted to hear that the project is now closing in on a 75% completion level. Thirteen of our community's 20 buildings are presently on the new water distribution system along with their relocated meters. The meters are now located in areas where the Waterworks crews will have much better access to manage, operate and maintain them.

The new 4 inch water lines and additional valves will provide a better level of water pressure and, most importantly, improved fire flow protection. This is an improved level of protection and an asset to Ventura Villas.

This ongoing MPW capital improvement project, as I said earlier, is continuing to make great progress with hopes for its completion of all the buildings sooner than September...hopefully!!! Barring any unforeseen problems or delays.

As a member of the Board of Directors of the Ventura Villas POA, it has been my sincere pleasure to be working with the Engineers of MPW along with Anson Construction Company, and most importantly with residents of our great Ventura Villas Community, as this project continues to move forward. Your patience and understanding has been appreciated.

Focus on Water Project and Landscaping: As you are aware, the ongoing water improvement project has caused disruption in our landscaping. As the project has progressed the landscapers are now able to catch up on the maintenance of our beautiful landscape. Going forward the landscapers are implementing a plan to address ongoing concerns with our landscaping including trimming bushes and hedges throughout the community. This will take several weeks to implement. Please be patient and remember that overall the water

improvement project is an immense asset to the community and our landscaping is going to be beautiful going forward.

Other Landscaping Issues:

All residents should be aware that vines and other growth on the walls must be removed by the residents . This growth is harmful to the wall surface and repairs are the responsibility of the homeowner and not the POA.

Bushes in the residents' limited common area should be no higher than 6'. Also vines and other growth on the fences should be kept neatly trimmed by the residents.

Please note the new fence for Maintenance at the Pool and Clubhouse. This will provide added security to these areas.

Recipe for Baked Beans Served at Last "Happy Hour"

```
I small onion, diced
I lb. hamburger
4 slices bacon (optional)
4 c. white sugar
3 c. brown sugar
3 tsp. dry mustard
1/2 c. catsup
I tsp. vinegar
I can pork and beans (I use Bush's Original 28 oz.)
3 cans your choice of other beans 15 oz. each
(I use dark kidney, Great Northern & baby butter beans)

- 1. drain all beans except port and beans. Stir together and set aside.
- 2. sauté onions, add hamburger, brown and drain
- 3. fry bacon, drain and cut into pieces; mix with hamburger
- 4. add remaining ingredients to meat mixture and stir well
- 5. Combine meat mixture with beans; bake at 375 for one hour; (stir once so beans don't get dry on top)

Use 2-quart casserole or 9 x 13 dish
